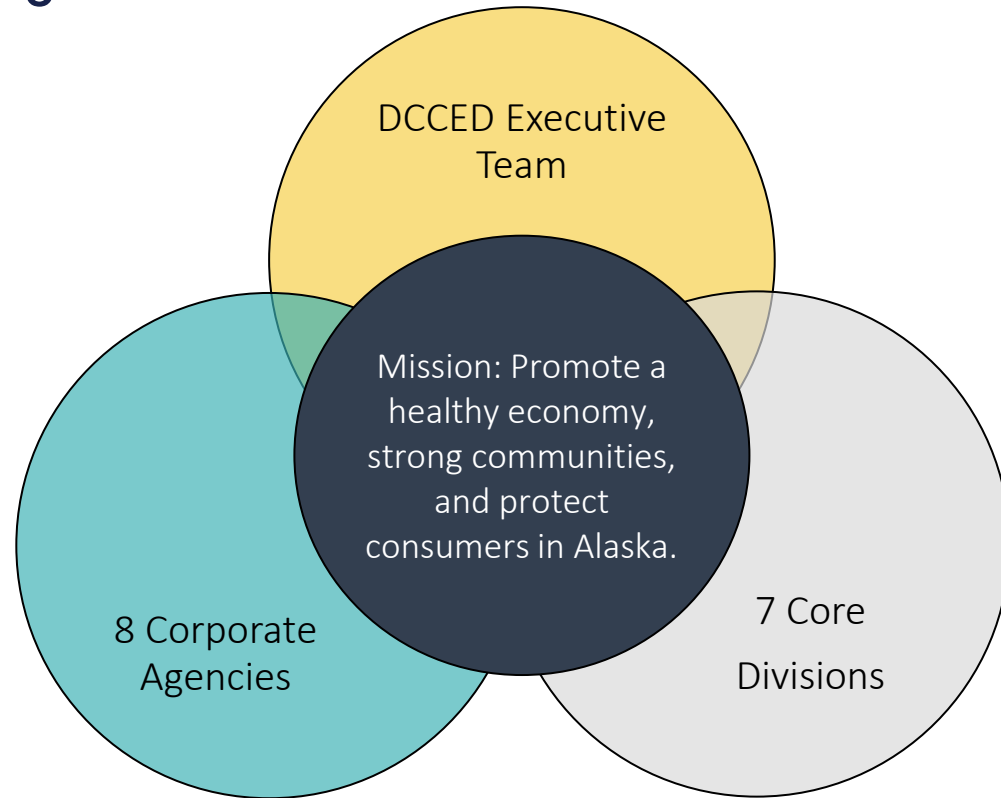

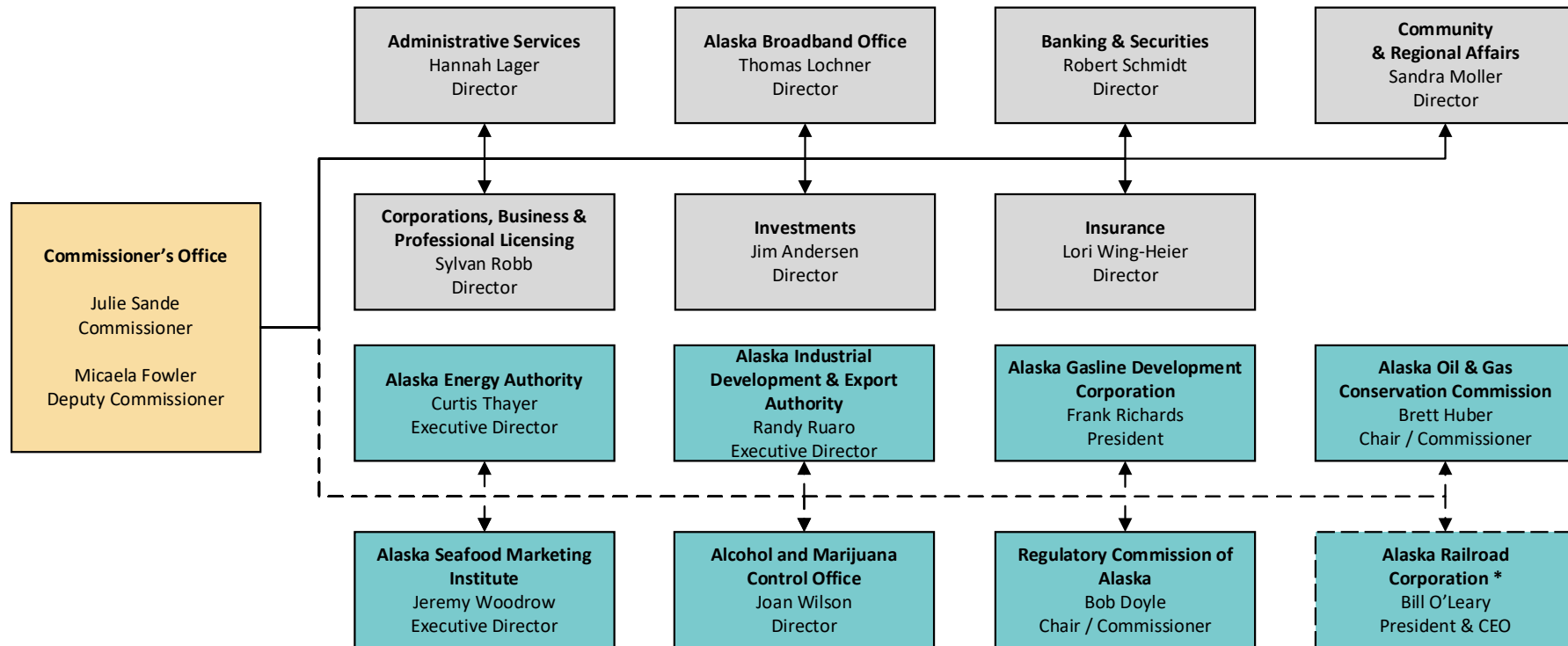

Department Structure



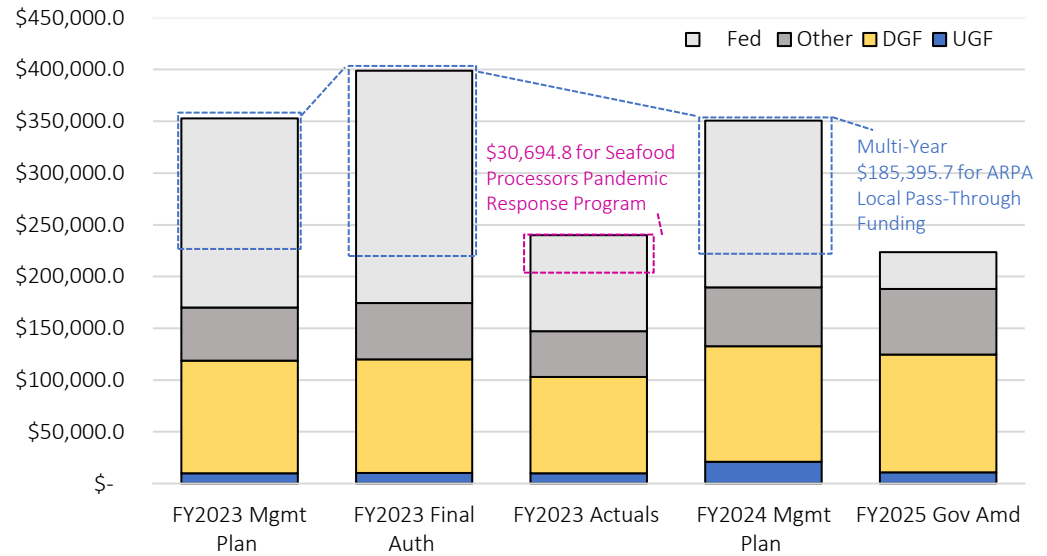
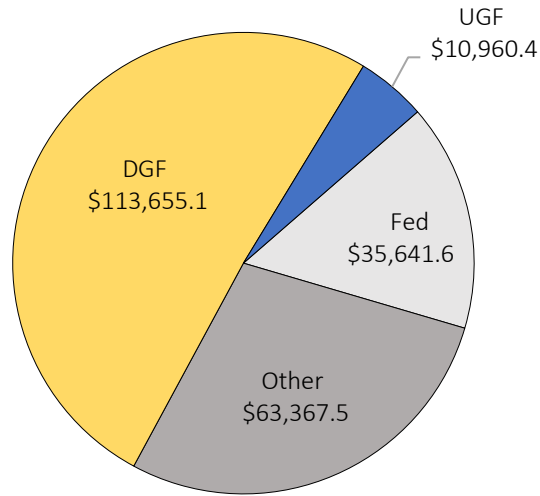

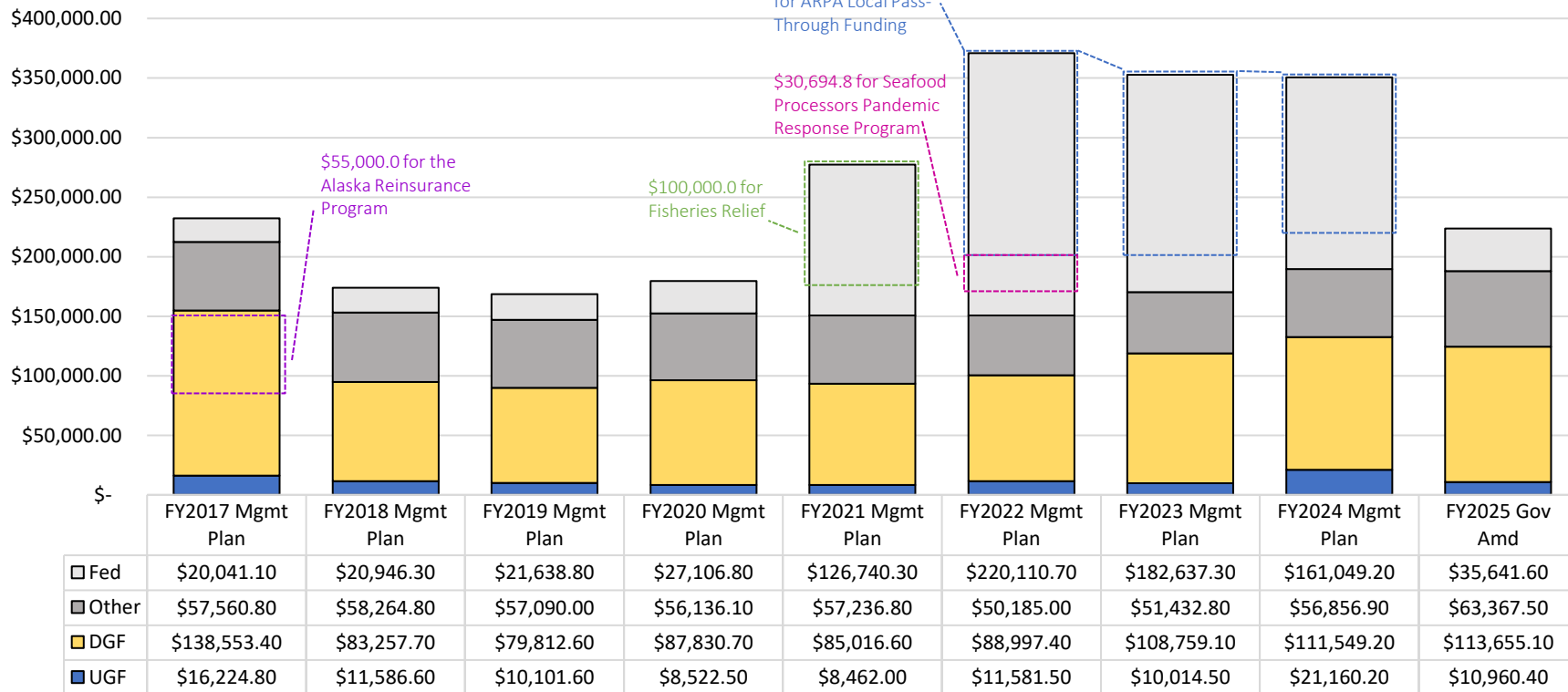

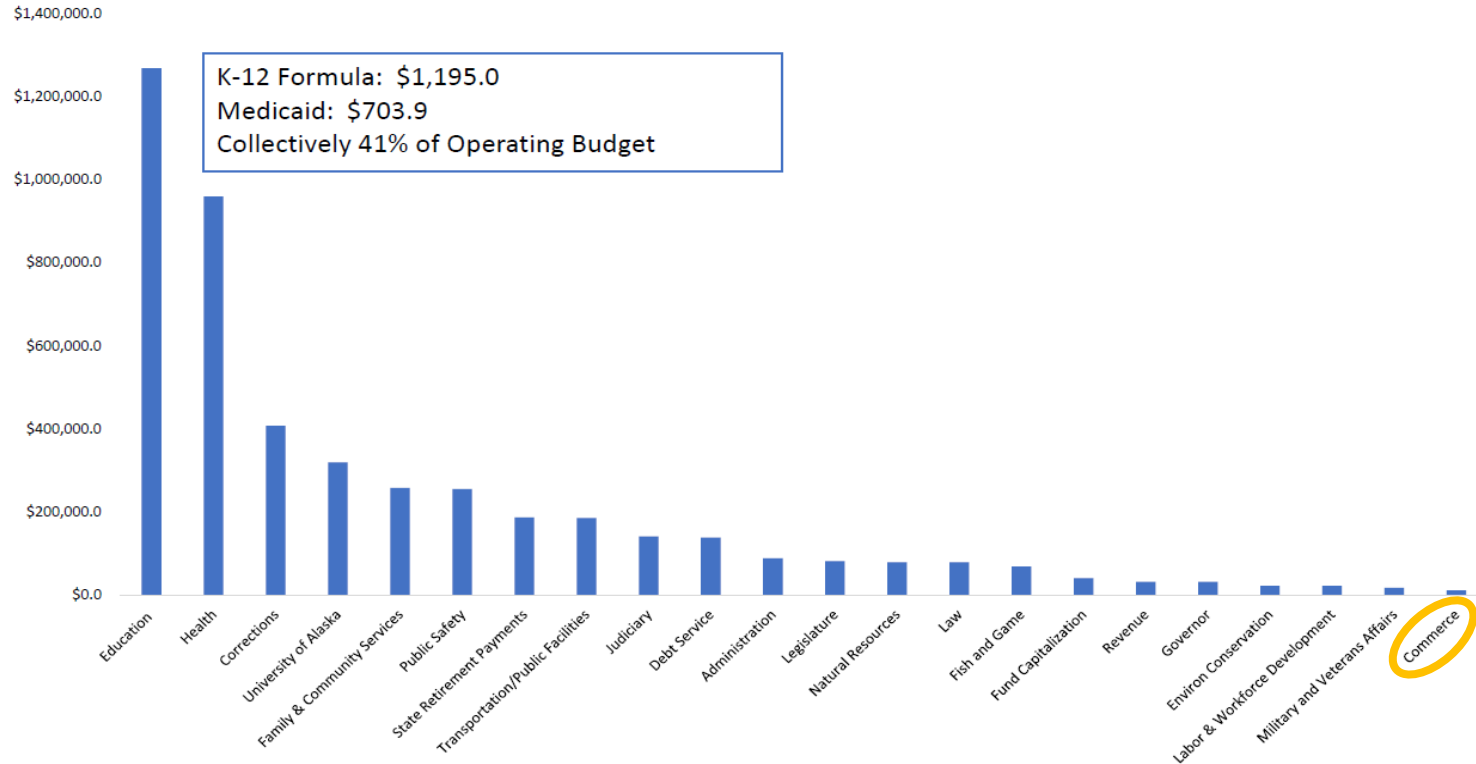

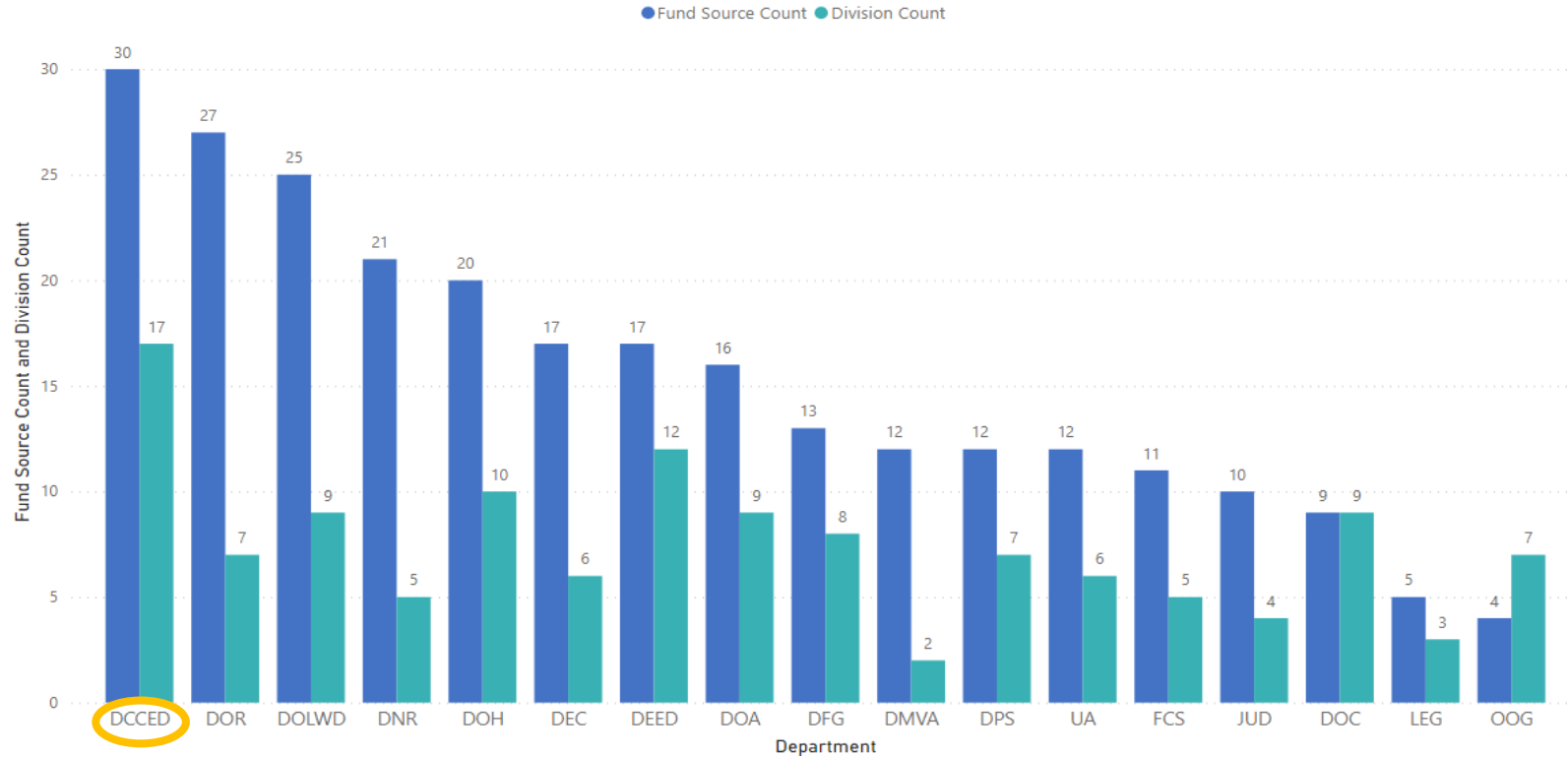
