



AIDEA, state representatives and supporters of the access road claim that this will open up the western Susitna Valley for hunting, fishing, and recreation. If this is true, there will need to be management of the recreational access and facilities - pull outs, trash, toilets, trails, etc. and staffing (funding) to manage the facilities. Will it be designated and managed as a state or borough recreation area or park? If not, it will be difficult for recreationists to find places to pull off to avoid the equipment and large trucks that will be moving along this industrial access road hauling heavy loads. I have heard this could happen at a rate of a truck every 12 minutes. This would create extremely dangerous conditions and sets the state and borough up for land management and multiple use issues - at the same time that the governor is trying to limit public input on these lands by eliminating the Recreational Rivers Management Plan advisory board. Industrial access and recreational access do not mix unless there is extensive planning involved and even then it is likely to create user conflicts.

In the late 80s I worked for DNR on the Recreational Rivers Management Plan - primarily with various user groups and potential conflicts with logging interests. A great deal of work was put into this effort. We really should learn from this experience and plenty of others - mixing development and recreation on our public lands is difficult, takes serious funding and planning, and will very likely become contentious.

It should also be noted that hunting pressure in the Susitna Valley has caused the closure of area 16B to moose hunting. Increasing access to hunting is not sustainable at this time. The proposed road crosses many salmon streams in this salmon-rich area that we all depend on for food. It is difficult to mitigate damage to these streams.

Construction of bridges, erosion and dust from this traffic will damage important salmon habitat. The stakes are high.

Alaska's state-owned public lands are a resource that we all share. It is misleading to claim that a benefit of building this industrial access road will increase recreational access in Alaska. I urge you to vote no on SB 199/HB 282.
