BILL NO. HB 298

Analysis

This bill amends the warning sign requirements for alcoholic beverage licensed premises to require the posting of a warning that "Alcohol use can cause cancer, including breast and colon cancers."

The Alcohol and Marijuana Control Office (AMCO) prints required warning signs and provides them to alcoholic beverage licensees. If adopted, this bill would require AMCO to replace existing signs. In addition, AMCO will need to update and notice associated regulations. The cost of these changes will be absorbed by AMCO's existing authority.
