FISCAL NOTE ANALYSIS

BILL NO. SB 164

Analysis

SB 164 would amend AS 41.21.026(d). Currently this statute provides a free annual camping pass to a disabled Alaskan veteran (DAV) of this country. SB 164 would amend the statute to extend the disabled veteran permit to any developed facility with a parking area with a restroom and make the permit valid for the life of the permit holder.

Currently, the Division of Parks and Outdoor Recreation (DPOR) issues DAV permits under AS 41.21.026(d) that are valid for a 5-year cycle (2023 - 2027). The current estimated benefit provided by these permits to disabled veterans of the country is \$350,000 per year. Currently, DPOR has 1750 active DAV passes in use.

Facilities and parking locations are additional areas that the Division of Parks and Outdoor Recreation (DPOR) collects revenue (general fund program receipts – GF/PR) to keep facilities clean and open to the public. Annual Parking passes are currently \$60 per year. Facility rentals happen throughout Alaska with group sites, pavilion rentals, and other recreational sites. Facility rentals also include a reservation fee via DPOR's third party reservation vendor. A system would need to be created to track and categorize the use of facilities and the issuance of a facility permit.

The Division estimates 4,000 annual parking permits set at \$60/year will be lost due to this change, which equals \$240,000; and an additional loss of \$10,000 related to rental of limited public reservable facilities. In total, the Division will lose \$250,000 in program receipt revenues which would need to be replaced by unrestricted general funds (UGF). The fiscal note reflects a fund source change from GF/PR to UGF accordingly.
