FISCAL NOTE ANALYSIS

STATE OF ALASKA
2024 LEGISLATIVE SESSION

BILL NO. SSHB194

Analysis

This bill amends AS 37.07 the Executive Budget Act to measure and achieve the service, program, and financial goals of the State. It would require the budget to include service, program, and financial goals and be organized by service or program and include service and program costs and desired measurements for each service and program. Each request must include details on unit and performance costs.

This bill changes the date of a newly elected governor to submit their annual budget by January 15, rather than the standard December 15 deadline.

It changes the requirement that a fiscal plan shall be submitted for the succeeding three years rather than 10 fiscal years. The Office of Management and Budget (OMB) works with agencies on a wide variety of deliverables during the current budget process. It is unclear, at this time, the workload the consensus councils would create for departments and the OMB, therefore, an indeterminate note is submitted.
