13 AS 14.30.174(b);

17 (a) Notwithstanding AS 14.30.171(a)(3) and (5), a behavioral or mental health
18 professional working within a public school system may, in compliance with federal
19 education law or applicable state law,

20 (1) recommend, but not require, a psychiatric or behavioral health
21 evaluation of a child; [AND]

22 (2) recommend, but not require, psychiatric, psychological, or
23 behavioral treatment for a child; **and**

1 **(3) obtain informed consent from and provide behavioral or**
 2 **mental health services to a child who is 16 years of age or older.**

4 (a) Except as prohibited under AS 18.16.010(a)(3),

5 (1) a minor who is living apart from the minor's parents or legal
 6 guardian and who is managing the minor's own financial affairs, regardless of the
 7 source or extent of income, may give consent for medical and dental services for the
 8 minor;

9 (2) a minor may give consent for medical and dental services if the
 10 parent or legal guardian of the minor cannot be contacted or, if contacted, is unwilling
 11 either to grant or to withhold consent; however, if [WHERE] the parent or legal
 12 guardian cannot be contacted or, when [IF] contacted, is unwilling either to grant or to
 13 withhold consent, the provider of medical or dental services shall counsel the minor
 14 keeping in mind not only the valid interests of the minor but also the valid interests of
 15 the parent or guardian and the family unit as best the provider presumes them;

16 (3) a minor who is the parent of a child may give consent to medical
 17 and dental services for the minor or the child;

18 (4) a minor may give consent for diagnosis, prevention, or treatment of
 19 pregnancy, and for diagnosis and treatment of venereal disease;

20 (5) **a minor who is 16 years of age or older may give consent to**
 21 **receive outpatient behavioral or mental health services from a behavioral health**
 22 **professional or mental health professional; a behavioral health professional or**
 23 **mental health professional may not prescribe medication to a minor receiving**
 24 **services under this paragraph without the consent of the minor's parent or**
 25 **guardian; during the course of treatment, the behavioral health professional or**
 26 **mental health professional shall contact the minor's parents and offer to provide**
 27 **services to the family, unless there are clear clinical indications that doing so**
 28 **would be harmful to the minor receiving services, in which case the behavioral**
 29 **health provider or mental health provider shall document those concerns in the**
 30 **counseling record; in this paragraph,**

31 **(A) "behavioral health professional" has the meaning given**
