House Bill 168 Sectional Analysis

Local Option Sectional Analysis

Section 1. Includes the new local option (option 6) in the statewide database.

Section 2. Includes the new local option (option 6) in allowing for a community delivery site in addition to the allowable shipment to a person's residence. Applies to shippers.

Section 3. Includes the new local option (option 6) in restrictions on the amount of alcoholic beverages that can be shipped per month to a person residing in a local option community. 10.5 liters of distilled spirits 24 liters of wine, half barrel keg of brewed beverages (beer), 12 gallons of brewed beverages.

Section 4. Includes the new local option (option 6) in the importation rules.

Section 5. Includes the new local option (option 6) in criteria for denial of a new license or endorsement.

Section 6. Includes the new local option (option 6) in criteria for denial of a new permit.

Section 7. Creates the new local option. Allows for a municipally run liquor store while leaving bars and restaurants to the private industry.

Section 8. Includes the new local option (option 6) in ballot requirements for a local option election.

Section 9. Includes the new local option (option 6) allowing for a community delivery site in addition to the allowable shipment to a person's residence. Applies to municipalities.

Section 10. Includes the new local option (option 6) for:

- (1) Reducing amounts that may be shipped in
- (2) Setting amounts of possession that trigger a presumption of intent to sell.
- (3) Criminal charges based on amounts of alcohol involved.

Section 11. Includes the new local option (option 6) for rules pertaining to the issuance, renewal, and transfer of licenses.

Section 12. Includes the new local option (option 6) for rules pertaining to the issuance, renewal, and transfer of licenses for municipal package stores.

Section 13. Includes the new local option (option 6) in municipal ordinance provisions.

Section 14. Effective date to coincide with implementation of the title 4 rewrite (32nd Legislature)
