Senators:

I am writing to urge you to pass SB73. I served 8 years on the AELS Board and understand the only reason for licensure is to protect the public safety. The Interior Designers work on interior construction, which has many life safety issues requiring qualified professionals. Currently, those designs require an architect's stamp. However, interior designers have the education, experience, and examination to ensure that they are qualified to do that work without supervision or oversight. Registering interior designers will allow the public additional options for the professional to perform that work.

As you are probably aware, the costs of the licensing boards are borne by all the licensees. There are currently 21 active NCIDQ certified individuals among the 54 total certified individuals with Alaska addresses. You can assume that there will be an equal number of nonresident Alaska licensees based on the percentages of resident and nonresident licensees for the other disciplines governed by the AELS Board. So, there should be about the same number of interior designers as mining engineers and landscape architects, both of whom have designated seats on the Board.

The additional expense for the new discipline and the Board changes will be minor. They will include membership in the national interior designer examination group, their annual meeting expenses, and Board travel expenses. Based on the AELS Board annual report, that would amount to about \$18,000 in additional annual costs to the AELS Board, which has an annual budget of about \$600,000. Given about 7800 registrants under the AELS Board purview, this will result in less than a \$5 increase in the biennial licensure fees.

I understand that the fiscal note for this bill includes funding for a second licensing examiner position. This is necessary because of the staff workload for the current number of registrants, not any additional work for 50-100 new interior designer registrants.

Thank you for considering this issue and, hopefully, moving it on towards passing this session. It is time. Please let me know if you have any questions.

Dear Senator Olson,

As an Architect, Registered and practicing in Alaska for 46 years, I strongly recommend passing SB 73. I have supported this initiative for several years now and I ask Senate Finance to pass this legislation. There are many reasons that I support this legislation. Of significance for your consideration are:

1. As an architect, I want buildings in Alaska to be as safe as possible. SB 73 supports this goal.
2. The Department of Defense (DOD) and the Core of Engineers (COE) now require that Interior Designers who provide services on their projects in Alaska be Registered Interior Designers. Given the increasing number of significant Military projects in Alaska, if this professional registration is not available to Alaska citizens, this work will necessarily have to be contracted to designers who are registered outside of Alaska.
3. Currently, Alaska Architects hire Interior Designers who are not registered and do not stamp the documents they prepare. Architects then stamp these documents and assume all the professional liability, accordingly, adding an unnecessary layer of review and fees to the project.
4. Credentialed Alaska Interior Designers provide services that affect Public Health, Safety and Welfare. They want the option to become Registered Professionals, required to stamp, sign, certify and be legally accountable for their work. This removes the additional, unnecessary layer of review, certification, and fees by architects. I emphatically agree. SB 73 accomplishes this, enhancing the safety of buildings in Alaska.

In conclusion, I want to thank you and the Committee for favorably considering this Legislation.

RE: SB73 - An Act to Register Interior Designers

Dear Co-Chair Senators Stedman, Hoffman, and Olson:

I hope you are recharging yourselves during the legislative interim. At the close of the session in May, SB 73, an Act to Register Interior Designers, was reported out of the Senate Labor & Commerce Committee and moved on to the Senate Finance Committee. The Alaska Board of Registration of Architects, Engineers, and Land Surveyors (AELS) has been actively reviewing this bill and took action at its May 10, 2023, meeting that I would like to make you aware of.

The AELS Board acted on the following issues related to CS-D of SB73 and requested that these be forwarded immediately to the Senate Labor and Commerce Committee to be considered at a hearing on the bill that occurred the same day. The bill was reported out without public testimony, so I am forwarding these actions to the Senate Finance Committee for consideration.

1. The Board does not recommend adding the profession of interior design to 08.48 (AELS Board).
2. If SB 73 is advanced by the legislature, the AELS Board offers the following recommendations to CS-D:
 - Remove all references in the bill to AELS Board make up (Sections 1, 2, 3 and 38).
 - Remove item (15) of Section 27.
 - In Section 30, delete (B) and revise (D) to meet the following: *"review of drawings and specifications of interior spaces made by regulatory agencies."*
 - In Section 37, revise to read as follows: *"Sec 37. TRANSITION: CURRENT INTERIOR DESIGNERS. Notwithstanding this Act, a person working as an interior designer before the effective date of this Act may continue to practice interior design in the state until 90 days after the effective date of regulations established in 12 AAC 36 or 2 years after the effective date of this Act, whichever comes first, at which time they must register if they wish to practice registered interior design as described in AS 08.48.341."*

The AELS Board has discussed the topic of interior design regulation at length for more than 3 years and held 2 special meetings on SB 73 during the 2023 legislative session. We have also raised concerns through written and verbal testimony during hearings on both SB73 and its predecessor bill from the 32nd Alaska Legislature, HB 61. While opinions of individual AELS Board members vary, the majority do not support adding the new profession of interior design to AS 08.48, the statute that authorizes the AELS Board. Discussion encouraged interior design to be regulated under a different framework if regulation is needed or desired.

We appreciate being allowed to engage in discussion about this legislation that, if approved, will add to the Board's responsibilities. Please contact me if you would like more detailed information, and I hope you are having a great Alaskan Summer! Sincerely,


