Dear Representative Allard,

I am in full support of HB 183. I have emailed this testimony in before and nothing has really changes in my stance for women's sports. So here it is again:

Title IX brought about important rights for women in sports and if transgender males are allowed in women's sports everything that was achieved with Title IX will disappear (see excerpt of an article on Title IX below).

TITLE IX'S IMPACT

The impact of Title IX on women's sports is significant. The law opened doors and removed barriers for girls and women, and while female athletes and their sports programs still have fewer teams, fewer scholarships, and lower budgets than their male counterparts, since Title IX's passage, female participation at the high school level has grown by 1057 percent and by 614 percent at the college level.

The impact of Title IX stretches into professional sports as well. More opportunities have emerged for young women to turn their sport into their career, particularly in the WNBA. Collegiate and professional coaching opportunities have increased as well.

Billie Jean King created the [Women's Sports Foundation](#) in part to protect the sports side of Title IX.

Title IX remains the only law that grants women any kind of equality in America.

Even with a sex change surgery and hormone therapy there are physical aspects like bone density and greater physical strength that will not change in a transgender male, putting the person at a great advantage in competition with women that is simply unfair.

To make it practical: we celebrated Lydia Jacoby's gold medal in the Olympics not too long ago. One of our own Alaskan incredible women athletes. That would most likely never have happened if a transgender male would have competed in the same swimming competition as Lydia.

The argument is being made that it will gravely affect the self esteem of the transgender person if they are not allowed to compete in women's sports. What about the self esteem of the women's athletes? Why would they put all the hard work in to compete when their opponent in the competition has such a huge and unfair advantage? That is a huge blow to their self esteem. By allowing transgender males to compete in women's sports you are telling all women that their hard work and accomplishments mean nothing and one person's self esteem is more important than another person's self esteem. And that is never ok.

Please vote "yes" on HB183.

I am writing to you today in opposition to House Bill 183.

As we all know, school years are some of the most formative years of our lives. Participation in extracurricular activities helps students form bonds that have the potential to last lifetimes. Situations that occur at school have a profound effect on these students. Unfortunately, trauma inflicted during socialization at school can sometimes be the deciding factor in the life of a student.

The students that are hurt the most by HB 183 may already be struggling with mental health as well as a variety of other issues. This bill will single these students out for further discrimination. The greatest injustice of this bill is that it originates not with the children it is intended to serve but rather from biased government and state officials. That is why I am writing to you, to be a voice for these students in an arena they don't even have direct access to.

School years can be some of the hardest times for a youth that feels isolated or excluded, which is just what this bill will do. Even though it is apparent this bill is targeting trans youth, I want you to be assured that it has the potential to affect every single student at a school.

I am a woman, and mom, who has benefited from sports in my life, and who was also a beneficiary of Title 9. I understand the concern of a small handful of athletes however I am opposed to HB 183.

My children, a boy and a girl, have spent their whole lives in Fairbanks schools. What they are concerned about is:

- Wildfire smoke and climate change
- Air quality
- The possibility of being shot at while at school
- The stress and fatigue their teachers are under because of a lack of school funding

The Alaska I love is a live-and-let-live state where my neighbor can keep his 20 goats and a full machine shop on his property, and I can do as I like, within zoning, on my property.
