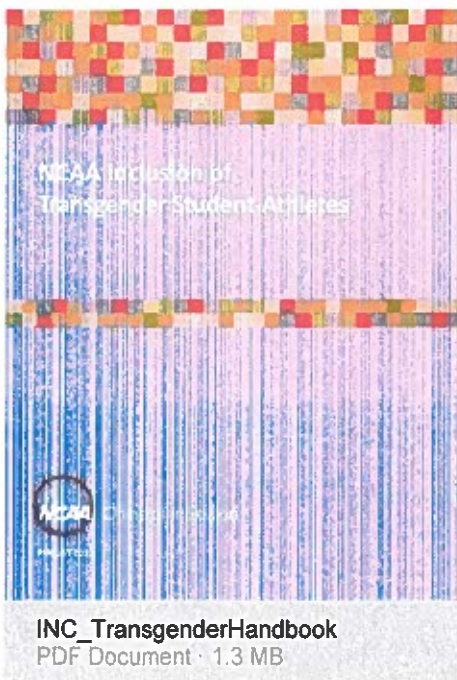

It really is "not a thing" Needless to say retired military, I was afraid I was losing my tact and composure due to the frustration of politicians exaggerating or creating issues out of ignorance, or worse yet for political gain. That is why I decided to draft this email to send. I do not wish to offend. However, 2 minutes on an Internet search gave me some eye-opening numbers. We have roughly 300,000 trans youth in the United States. Current census data list the overall population of the United States as 383 million. Out of those 300,000 a majority over 50% are trans male. So if you generously assign half as trans female we're looking at 150,000 kids nationally! According to the 2019, US census bureau Alaska is .02% of the US population in total. According to the 2019 Alaska population estimates we have steadily maintained approximately 200,000 young people between the ages of zero and 19 since 2010. Do you see where I am going with this. I don't even need a calculator to know that the number of trans girls wanting to play sports in Alaska is statistically insignificant. I could probably spend another 10-20 minutes on the Internet, but I doubt that I would come up with a number greater than a few dozen transgender kids that want to play sports. Please tell me that you are not spending all this money, time and effort on this non-issue, when there are very serious issues; real child abuse, hunger and poverty, educational funding, etc in Alaska. I can go on, but I want to keep this short. There is NO issue! Please stop wasting taxpayer time, money, and effort on this, please vote against HB 183.
