## FISCAL NOTE ANALYSIS

**BILL NO.** HB 202

### Analysis

This bill proposes to have every public school and school bus have a supply of at least two doses of the opioid reversal drug naloxone available and that someone with training be available to administer naloxone and call 911.

Training would be provided to each school district from the Department of Health who can then train required staff.

This bill does not specify that Department of Health will provide the naloxone to school districts, so at this time, Public Health does not anticipate any fiscal impact.
