BILL NO. HB 183

Analysis

The bill requires public schools to designate school-sponsored athletic teams or sports as male, female, or co-ed and requires participation in a female sport to be based on the participant's biological sex. The Department of Education and Early Development does not anticipate fiscal impact from this legislation.

This bill takes effect immediately under AS 01.10.070(c).
