Analysis

This bill increases the base student allocation (BSA) in AS 14.17.470 from \$5,960 to \$6,960, providing additional state aid for districts through the Foundation Program as an appropriation to the Public Education Fund.

As a division of the Department of Education and Early Development, Mt. Edgecumbe High School's (MEHS) state aid is budgeted as interagency receipts. This fiscal note increases their budgeted interagency receipt authority to match the estimated allocation from the Public Education Fund. The current projected FY2026 allocation is \$2,650.2 (thousands), with the proposed FY2026 allocation under this bill to be \$3,356.7 (thousands), resulting in an increase of \$706.5 (thousands).
