Last week the House Finance Subcommittee proposed reducing ANSEP's base funding. This would have serious consequences for the ANSEP Acceleration Academy High Schools, as well as the students and communities it serves across Alaska. ANSEP Acceleration exists to support students as they pursue their dreams. The way it does this is unlike any other program in the country, and something that funding cuts jeapordize.

You see, ANSEP Acceleration works to eliminate barriers to higher education, which leads to students across socioeconomic backgrounds moving through higher education and providing exceptional impact to their communities. It does this by providing robust wrap-around support while staff connect students with opportunities for educational and professional growth. In Anchorage, we have a number of ways we do this.

- Recitations and Tutoring are the core academic support services we offer. We employ staff who are subject matter experts in various fields who can serve as trusted adults while they lead study groups. The students work together to fully ensure they understand the foundational concepts of their classes. Outside of this, staff connect with students on a weekly basis to check in on their grades and well being, which also provides them opportunities to connect with the students and offer individualized academic support.
- **Meals** are provided to our students because we believe that it alleviates any concerns from students regarding food insecurity, for we understand that students struggle in all facets when they're more worried about fundamental human needs. By removing this concern, the students can spend their school days focused on learning, rather than where their next meal may come from.

We also strongly believe that our students need to learn soft skills to leave our program prepared for the professional environments they'll find themselves in. That and our recognition that students in high school thrive when they feel safe and welcome in the community leads to a number of our programs aimed around social emotional learning. We've included our students to help us build clubs and organizations that fit their interest, such as STEM and Robotics Clubs, Model United Nations, and Service Community Organization. We also provide extracurricular activities that are related to science, engineering, and business. One such example is when I connected with a local business to teach our students the science behind building an Escape Room, as this paired their interest with the educational components behind it. We also provide opportunities for them to learn from presentations every Friday, such as when a local Financial Advisor came to our Acceleration Academy to teach the students about investments and compound interest.

I'm sure you've received a number of emails about how ANSEP has transformed lives. My hope is you realize that people are doing this because they're worried that your proposed funding cuts will dramatically impact the way our program can support the future of Alaska

and, also, the United State of America. We're at the cutting edge of where education could go and saving the state millions of dollars in the process. This is a program that could transform the country as it lifts youth into work sectors that are currently in desperate need of skilled labor. It's extremely short sighted to take money away from that, and I sincerely hope you're smarter than that.

The local policies have had devastating impacts on people experiencing homelessness who continue to live in tents at the park.

I have also worked in Alaska Medicaid programs for 30 years and know the positive effects successful behavioral health treatment can have in people's lives, including full recovery, being functioning family members and spouses, raising their children, and sometimes turning into treatment providers themselves.

The behavioral health system needs investments that prevent people from multiple hospitalizations, incarcerations, and experiencing homelessness where their treatment needs are not met.

Alaska Medicaid is two years and \$15 million behind on updating rates that make staffing behavioral health agencies and providing more services possible.

Behavioral health services aim to treat the individual person and their whole family system. This has a greater impact for more Alaska residents than only the Alaska Medicaid recipient.

Please support increasing behavioral health funding in our state for more services to be available for the people and families who need them.

My name is Darlene Trigg, and I am a lifelong Alaska resident, a Nome Beltz graduate, a parent of three Nome Beltz graduates, and a grandparent with one grandchild attending Nome Public Schools. I am also the President of the Board of Education for Nome Public Schools.

I urge you to invest in public education in Alaska:

- An increase in education funding inside the BSA is crucial for children in Alaska.
- Funding for public education has not kept pace with inflation, and as a result, our
 schools have been forced to make difficult decisions that have impacted the morale and
 consistency of our children's education. Nome Public Schools has worked hard over the
 last several years to ensure that our reduced purchasing power doesn't negatively affect
 our students' ability to learn. However, the inconsistent funding outside of the BSA
 makes it very challenging for both teachers and the community to focus on our
 children's needs.



Good Evening, It was brought to my attention that we have an opportunity to strengthen the funding of the Infant Learning Program(ILP), which may expand services to more kids and their families. There is plenty of literature stating how important it is for early intervention and how impactful it can be for kiddos with challenges but you likely already know that. I want to share with you something that you might not know. Something before having a child with disabilities, I didn't know myself and that was, the Infant Learning Program isn't just for the child but it is for the whole family.

Our state insurance would not cover resources for Down syndrome, only autism. Thankfully we were told about ILP services that were affordable through ACCA (Alaska Center for Children & Adults). We expected them to only service Asher, challenging him physically and mentally, and that we would mostly be observers. They challenged the whole family! Through their leadership and support they equipped us to become Ashers physical, speech, and occupational therapists. By equipping us with the knowledge and techniques, Asher received therapy everyday. Once Asher received TEFRA I would have providers assess him but asked what their therapists would be doing to help him and it was what we were doing at home so we never utilized providers until years later when Asher needed more expertise than what we had. Thankfully by that time we had insurance that helped cover therapies for Down syndrome.

ILP is much more than just early intervention and ensuring children reach their full potential. It's empowering families, especially during times of uncertainty and helplessness. It's an opportunity given to families to become a team that support one another to achieve goals together. These families are strengthened by these challenges and having worked through them these individuals can impact the whole community. Our family has shared what we've learned and have become cheerleaders for others and their families in our community.

We will always be indebted and overflowing with thankfulness for the Infant Learning Program. I hope you recognize the importance and impact the ILP has in our community and advance the states support. Thank you for your time and continued support!

I was a teenager during those times in my life, so we have needed these resources since the 1990's. Seeing people you love suffer because of the lack of funding and available resources hurts on a deep level. Every role of every person that has ever helped my father or myself has been in the mental health field. Mental health is often over looked and not acknowledged that should be where the care starts period. Science has more than proven that without a healthy mental state, the rest of a human being declines. Effecting the rest of the whole being, causing other areas of the person to decline.

The homelessness and the help people need in this state is outrageous. Every single one of them means something to someone, and most of the folks experiencing these things are either not properly diagnosed or literally struggling with some form of addiction that keeps them in the state of mental and emotional distress. Some people I love will not even use benefits for being Alaska Native(Part of a Federally Recognized Tribe) because their significant other isn't and cannot receive help for not being Alaska Native(Part of a Federally Recognized Tribe). The cry for help cannot get any louder than it has been for decades. People's lives matter, and they are loved, they are not lost causes. They need the help that they have not been receiving.

Council's Key Budget Items to Support which are <u>not</u> included in the House Version of the Budget and <u>need your advocacy</u>:

- 1. Special Education Service Agency (SESA) \$480 K (DEED) The Special Education Service Agency (SESA) provides training and resources to special education teachers and school staff in rural Alaska who support students with Low Incidence Disabilities (LID), including autism, deaf and hard of hearing, vision impairment, deaf-blindness, emotional disabilities, and multiple disabilities. SESA's budget is based on total public-school enrollment, which is declining, while the number of students needing SESA's services continues to grow. This funding gap forces SESA to serve more students with fewer resources, and without an increase, they will have to implement a waitlist-violating federal law under the Individuals with Disabilities Education Act, which mandates timely special education services.
- 2. **Deaf Navigator Program \$75 K (DOH/SDS).** The Deaf Navigator Program provides essential support for Alaskans who are deaf, hard of hearing, or deaf blind, helping them navigate services and access resources. Originally housed at The Arc of Anchorage and now operated by Hope Community Resources, the program has never received a funding increase since its inception. Without this funding, critical support

for the deaf and hard-of-hearing community will be at risk, limiting access to communication assistance, advocacy, and essential services.

- 3. Functional Needs Coordinator, \$175 K (DMVA/Emergency Operations) Add \$175 K for an Access and Functional Needs (AFN) Coordinator within the State Emergency Operations Center (SEOC) so they can meet the emergency planning and response necessary for Alaskans with disabilities. Unlike most emergency operation centers, Alaska does not have an AFN Coordinator.
- 4. Human Services Transportation Grant Program--\$250 K (DOTPF/ACT)- Add \$250 K in GF/MH capital funding for the Human Services Transportation Grant program. This program was previously funded at \$1.0 M and is currently in the draft FY 26 budget at \$750 K.
- 5. Public and Community Transportation Match Funding—\$1.0 M (DOTPF) To maintain access to federal funding and sustain community transit, we request \$1 million in capital funds to assist transit providers in meeting their match obligations for federal grants.

Council's Key Budget Items to Support which <u>are</u> included in the House Version of the Budget (Tell Legislators "Thank You and keep in the budget"):

- 1. My name is Amy Simpson I am the director of Programs for Infants and Children or PIC, the Infants Learning program in the Anchorage area. I am a resident of Eagle River. I have been with PIC for 30 years as director and a speech language pathologist. I am here to voice my gratitude for the \$5.72 million increment to the ILP. This increment would provide some much-needed relief for 11+ years of flat state funding to the Infant Learning Program. It would also do something very important in that, it would allow the program to expand the eligibility criteria from a 50% delay to a 25% delay. We believe the program statewide would see a 77% increase in the number of children eligible for these important services.

Last year, providers at PIC had to tell parents of more than 100 children that although the children have a significant delay, they are not yet delayed enough to qualify for early intervention in Alaska. In fact, Alaska has the most restrictive eligibility of all states which is a 50% delay. This needs to change. Research indicates that nearly half of all children who received early intervention services do not need special education services beyond kindergarten. We believe this investment in ILP now would avoid \$34 million each year in special education costs for the state in the future.

Thank you for your time and I appreciate including the total \$5.72 million ILP increment in the final budget for the future of our kids and our state. I encourage you to support all early childhood programs including Childcare grants, Head Start, and Parents as teachers as well.

I also served as the Summer Bridge Program Director for ANSEP in 2021, which is ANSEP's pre-college summer component for high school graduates, where I worked closely with Acceleration Academy graduated high school students that were provided internships and beginning their careers where I was able to see firsthand their determination, passion, and motivation to succeed. Their drive to take on challenges and create brighter futures for themselves was inspiring, and I continue to give back to ANSEP by leading Snow Science and STEM activities for high school students during Career Explorations Week each year (see photos below).

ANSEP provides life-changing opportunities for Alaska's students, and reducing its funding would have a direct and negative impact on students and families across the state. From working with these students for many years, you get to feel their bow hearts that inspire them every step of the way. And now working with Arctic Research in Utqiagvik and across the Arctic Slope region, there is a need for these rural and indigenous students to be involved in the research, science, and engineering projects are affecting their home communities. I urge you to restore full funding for ANSEP to ensure this program continues to serve the next generation of Alaskan leaders.



I have been following HB 69, education funding, and now I understand we need to figure out how to actually fund it within the State Budget. I don't know exactly how or when to weigh in on the actual funding method for the increased BSA as that bill is still moving, now transmitted to the Senate Education Committee. But I believe school funding is so critical for our State, I appreciate the opportunity to testify to your committee.

I have previously testified with concern about excess funding of charter schools, or other types of programs that take money from our public schools. I feel that funding our brick and mortar neighborhood schools should be the highest priority.

We home schooled our daughter as we lived in the bush with no alternative. We did not expect the State to pay us education (BSA) money, or for "enrichment". We were serviced by Centralized Correspondence Study out of Juneau and appreciated everything that was mailed to us - including lesson plans, text books, library books and related materials. We mushed our dog team 7 miles each way to meet the weekly mail plane in great anticipation of the materials, including returned school work, graded papers and messages from our teachers. We were very grateful to have the CCS program available.

Our family supported our daughter's correspondence education with our time and expected nothing more from CCS or the State. If there are other Alaskan parents who wish to exercise "school choice", that's fine. But I feel they shouldn't expect the State to pay for that.

I particularly object to funding religious schools in clear violation of our State constitution. My parents sent me and my siblings to a Catholic school through 8th grade. But my parents paid for that.

I don't believe a fat PFD check is a higher priority than education. Our daughter is grown and we don't have grandkids in the State, but we still believe in funding schools ahead of our PFDs.

I am an anti-hunger advocate in Alaska. I volunteer weekly at a local food pantry. I see the growing need, and it scares me.

Our interfaith pantry allows people to select what they want to take from our shelves instead of us preparing a bag for them. We used to serve about 15-20 shoppers a week, who were responsible for feeding about 45-60 family members, but in the last year our numbers have doubled. There is regularly a line of a dozen people waiting for our pantry to open at 9:30 on Saturday mornings. Shoppers regularly speak of not being able to make ends meet so they have to rely on the indignity of food pantry shopping to provide for their families or themselves. We try to afford them the dignity of choice, but I'm afraid we are going to have to start imposing limits on what shoppers can take, as otherwise our shelves will be bare before the pantry closes at 11:00. We get most of the food we offer from the Southeast Alaska Food Bank, but even there, the amount of available food is declining, as grocery stores are being more cautious with donations in this economy.

I ask you to remember the hungry as you deliberate on the 2026 budget. Please continue to fund direct food purchasing programs like the recent \$1.5M Food Security Grant from the Department of Commerce, Community, and Economic Development as well as the \$1.5M for Food Bank and Pantry Relief Fund from the Department of Health. And please, please please consider funding initiatives that feed Alaska's children, such as summer EBT and free and reduced school meals. I also volunteer as a Reader Buddy at my neighborhood elementary school, and I clearly see that student nutrition is a valuable component of the bigger school funding picture. School is often the only place students receive a hot meal, and there are many children who would otherwise go without, which affects their ability to learn.

Alaskans don't deserve to be hungry. We are a wealthy state. We can provide this basic resource to all Alaskans in need. Prioritize food access in this spending plan!
