## FISCAL NOTE ANALYSIS

**STATE OF ALASKA  
2024 LEGISLATIVE SESSION****Analysis**

This legislation amends AS 16.05.255 by adding a new subsection that provides statutory authority for the Board of Game (BOG) to establish hunts limited to persons with physical disabilities.

Additional Division of Wildlife Conservation (DWC) staff time would be required to review any proposals, prepare relevant data, and develop department comments. Outside staff time, there is no fiscal impact other than updating website information, literature, and regulations as necessary to incorporate any new hunts limited to disabled persons as approved by the BOG. Those costs can be absorbed by the department, and we do not anticipate additional personal services costs for the Boards Support Section or DWC. Therefore, the department submits a zero fiscal note.
