Respected Members of the House Education Committee,

Please allow me to provide this letter to you in support of Karen Perdue, who is currently serving on University of Alaska Board of Regent, under her prior eight year term. As you know she will continue to do so until a confirmation is completed to re-appoint her for another eight years, or another individual is appointed.

You may not know of my background on this particular arena so let me briefly provide that. I was appointed to UA Board of Regents in 2011 and served till end of my term in December 2018. I was Chair of the Board of Regents for two years. I am a big supporter of higher Education and a proud double alumna of University of Alaska, Fairbanks. In my professional life, I am the former President & CEO of Denali State Bank, a bank I help start in 1986 and later led as its Chief Executive Officer and President from 2002 to 2012, at which point, I retired.

During my years as UA Regent, I was regularly asked about what I did, even from University staff and others in the UA system. There is a lack of understanding about the role of a regent. Also, there are some misconceptions about it as well. Did I get free tuition for myself and my family? NO. Did I get compensation for every meeting? NO. Did I get privileges like free use of Student Recreation Center? NO. Did I get free parking? NO. You get the drift!

What I did get was an opportunity to engage, advocate, understand, and provide oversight to this great institution. In my eight years of service, the good times were behind us, meaning we were no longer building new buildings, adding programs, adding staff and faculty, but were looking at budget cuts, shutting down programs, looking at where we could cut expenses, reduce rural and smaller campuses, trim down athletics. It was heartbreaking work, why? Because at the end of every decision, there were people involved, their livelihood at stake, their future at risk. In my tenure we had possibly more meetings than any other prior eight year term. We had two Chancellors retire, UA President retire, and Title IX became a huge and time consuming issue. There was anxiety, uncertainty, and a lot of concern about good people leaving our University. Students, who are and always will be our primary focus, were affected by all these decisions.

My intention in recapping this is to perhaps take the liberty of outlining for you in a brief manner that the role a Regent plays for eight years is not a walk in the park. It's a lot of work, lot of time that is required and we get to work with really tough issues. The Regents

are faced with challenges that are known, like budgets, deferred maintenance on aging infrastructure; (no money), student enrollment, student and faculty successes, and then those that come out of nowhere and suddenly become a huge issue.

When faced with challenging issues, as the University has in the past few weeks, it's not something that Regents take lightly. Every decision made will make some people very unhappy. However, the Regents are advised when they begin their term that their focus needs to be across the board, not geographically limited to promote their regions, and should absolutely be in the best interest of the University as a whole. That's the lens we look through when making tough decisions. I will tell you from experience, it's not easy, and we as regents are recipients of anger, votes of no confidence, and general hostility. It's not a good feeling for anyone, especially when the Regents are doing the best they can for the institution as well as complying with what's been thrust on them. Demanding that all Regents resign, will not remove this issue of compliance, as there are consequences to non-compliance. As you see, the issues facing the Regents are many, fraught with emotions, anxiety which leads to anger. All directed towards a group of volunteers!

With all that said, if there is someone who serves their eight year term and then wants to throw their name in the hat again for another eight years, it's because they have the University's best interest at heart. We have already established that this is not a glamourous or compensated position. My hats off to those who are good at what they do and want to keep doing it.

Karen Perdue is one of those individuals. She has served very well in the last eight years, she is a thoughtful leader, very astute, understands education, and works well with faculty, students, staff and partners well with the governance groups. Her professional and public service background is impressive. The knowledge and understanding that she has gained in the last eight years should not be lost to a new person who will start at ground zero. Please consider my letter as a vote of confidence for Karen Perdue.
