FISCAL NOTE ANALYSIS

Analysis

This legislation would expand the scope of practice for athletic trainers. Currently, athletic trainers can only treat, evaluate, assess, care for, rehabilitate, and recondition an athlete for an athletic injury or illness. "Athlete" is currently defined as an individual who participates in an athletic or sport-related exercise or activity; and "athletic injury or illness" is currently defined as an injury or illness sustained or exacerbated through participation in an activity, exercise, recreation, sport, or game requiring physical strength, range of motion, flexibility, body awareness and control, speed, stamina, or agility of a type sustained in association with sports participation as part of an education institution, professional sports club, amateur sports club, recreational sports club, or organization.

This legislation would expand the scope of practice so athletic trainers can work with any individual, not just athletes. In addition to evaluating, assessing, caring for, treating, rehabilitating, and reconditioning these individuals, athletic trainers will also be able to diagnose; they can provide these services for any injuries, illnesses, or conditions, rather than only for athletic injuries or illnesses. Increases in investigative or legal costs are possible. However, the Division of Corporation, Business, and Professional Licensing is unable to determine those estimated increases.

If the bill passes, the costs to amend regulations, printing, and postage will be absorbed within the division's existing budgeted authority.

Professional licensing programs within the Division of Corporations, Business and Professional Licensing are funded by Receipt Supported Services — fund source 1156 Rcpt Svcs (DGF). Licensing fees for each occupation are set per AS 08.01.065. The total amount of revenue collected approximately equals each occupation's actual regulatory costs.
