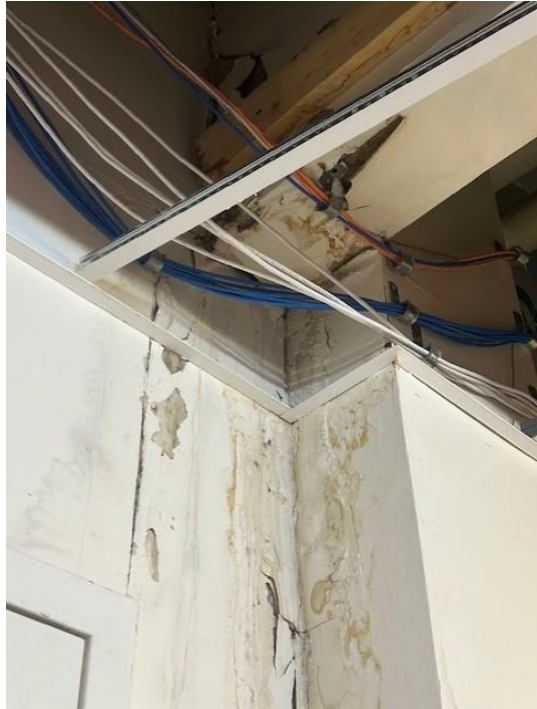
Current State of Alaska Schools

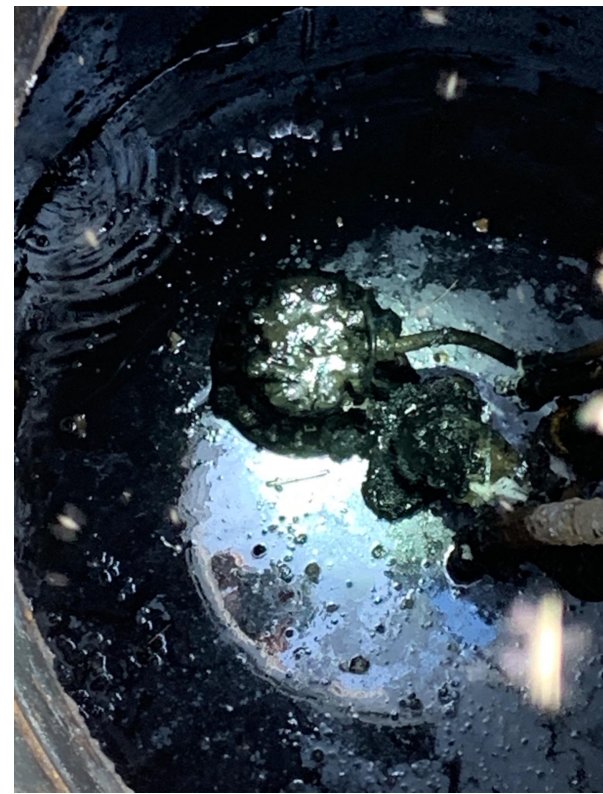

Proposed Solutions

- Increase state capital funding.
- Develop a long-term maintenance strategy.
- Ensure equitable resource distribution.
- Review and update the application process
 - Separate lists for REAA districts and Municipal/Borough districts
- Engineer and architect support provided by the state to districts that afford it
