

An agency shall be established by law in the executive branch of the state government to advise and assist local governments. It shall review their activities, collect and publish local government information, and perform other duties prescribed by law.

– Article X, Section 14 of the Alaska State Constitution

- To protect and educate consumers of financial services and promote safe and sound financial systems

Corporations, Business & Professional Licensing

- To ensure that competent, professional and regulated commercial services are available to Alaska consumers

Insurance

- To regulate the insurance industry to protect Alaskan consumers

Alcoholic Beverage and Marijuana Control

- A regulatory and quasi-judicial agency that controls of the manufacture, and sale of alcoholic beverages and marijuana in the state


Regulatory Commission of Alaska



Today, the Centers for Medicare & Medicaid Services (CMS) and the United States Department of the Treasury announced the approval of Alaska's 1332 State Innovation Waiver application. Alaska sought a 1332 waiver to implement the Alaska Reinsurance Program (ARP) for 2018 and future years in an effort to stabilize the individual healthcare market.



ANS History and Forecast by Pool






Economic Impact of Growth

Fairbanks North Star Borough	State of Alaska
4,000 jobs move to Fairbanks North Star Borough	5,000 new jobs created in the Fairbanks North Star
\$22 million in property tax revenues	No new revenues
\$10 million in new education expenses	\$25 million in new education expenses
\$12 million left for roads, emergency services, social services and other needs	\$5 million in increased costs for troopers, DOT, courts, prisons, Medicaid, child care assistance, etc.
New revenues exceed new expenses	\$30 million in additional expenses, no new revenues
Net gain as a result of economic growth	Net loss as a result of economic growth (in strictly financial terms)
