Analysis

HB 273 extends statutory authorization for the existing Marijuana Control Board (MCB) through June 30, 2024.

The Marijuana Control Board's mission is to control the cultivation, manufacture, and sale of marijuana and marijuana products in the state. To date there are 166 licensed marijuana businesses operating within the state of Alaska. An additional 93 businesses have been approved by the board and are preparing to become operational.
