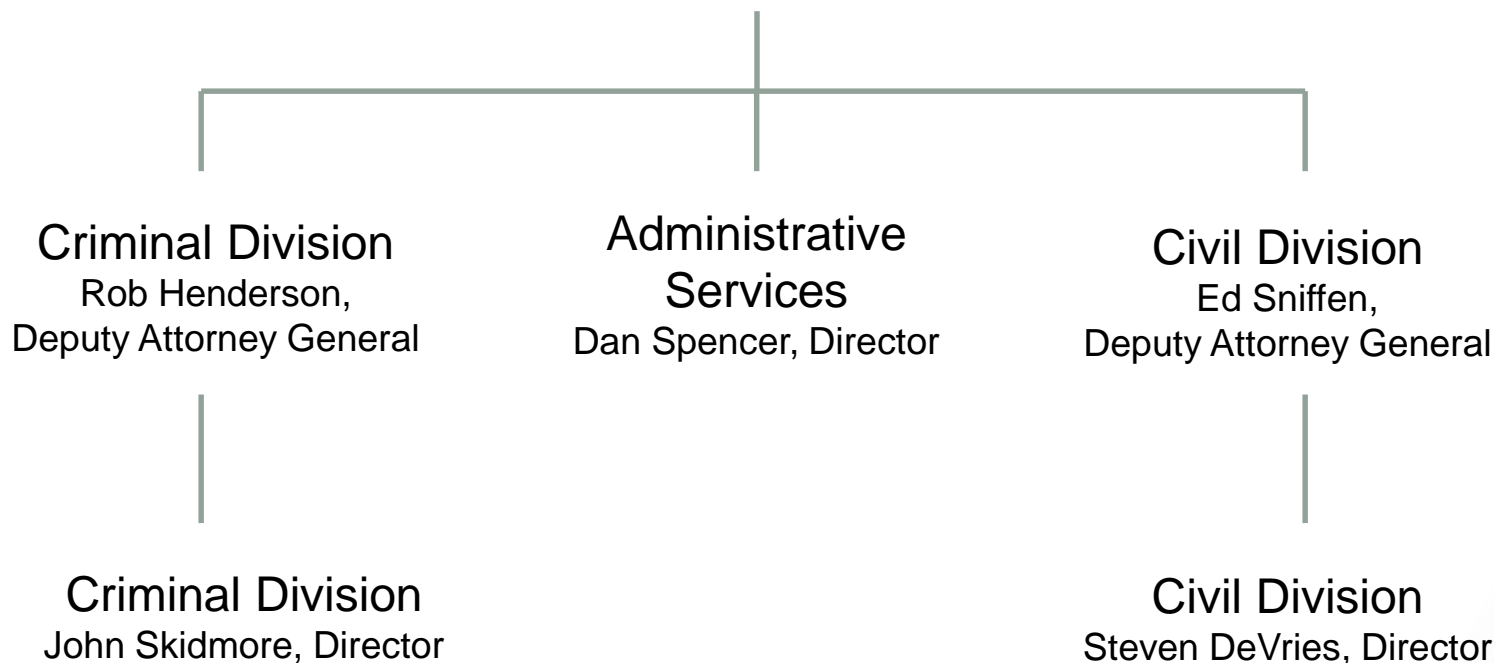

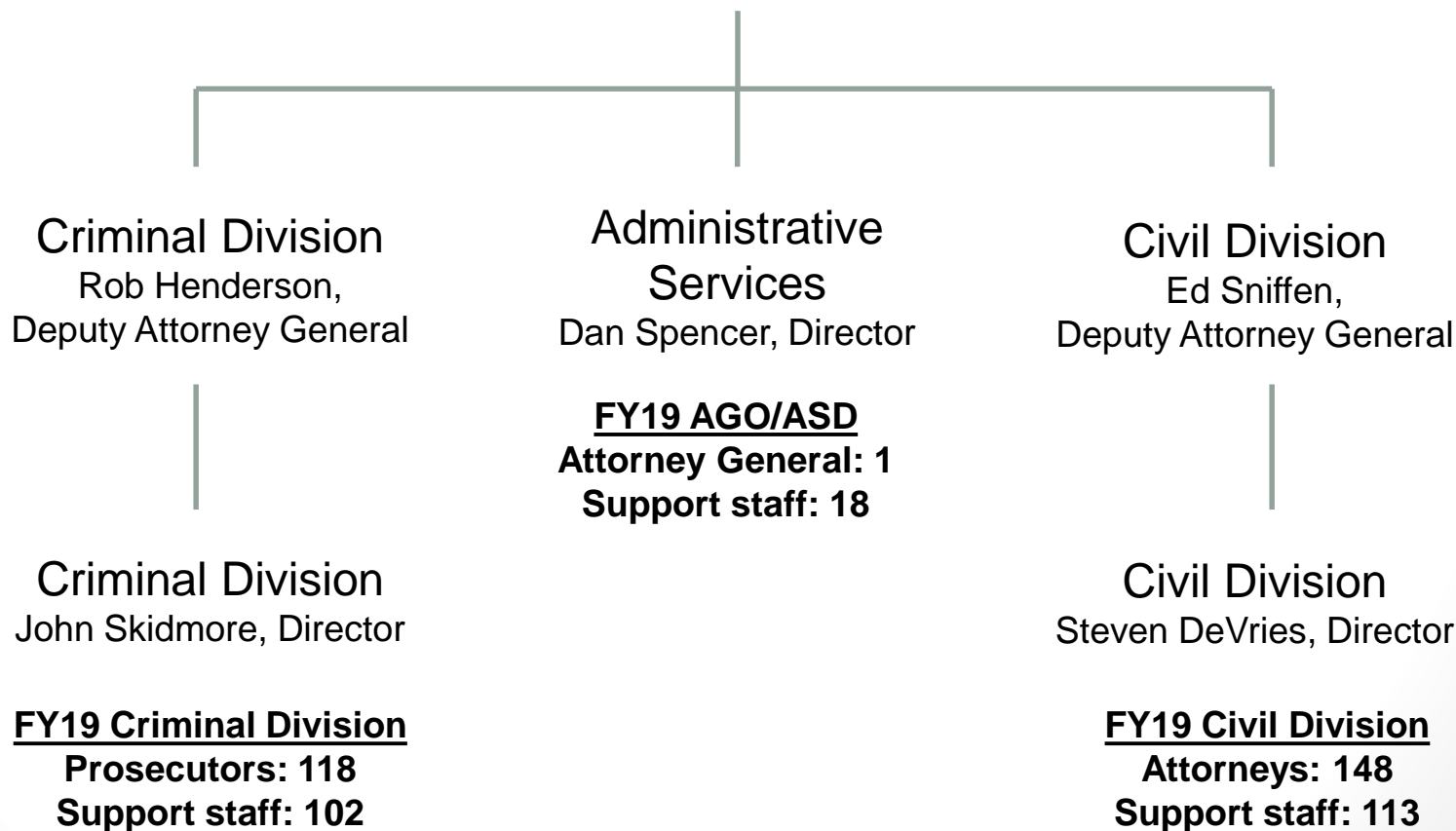

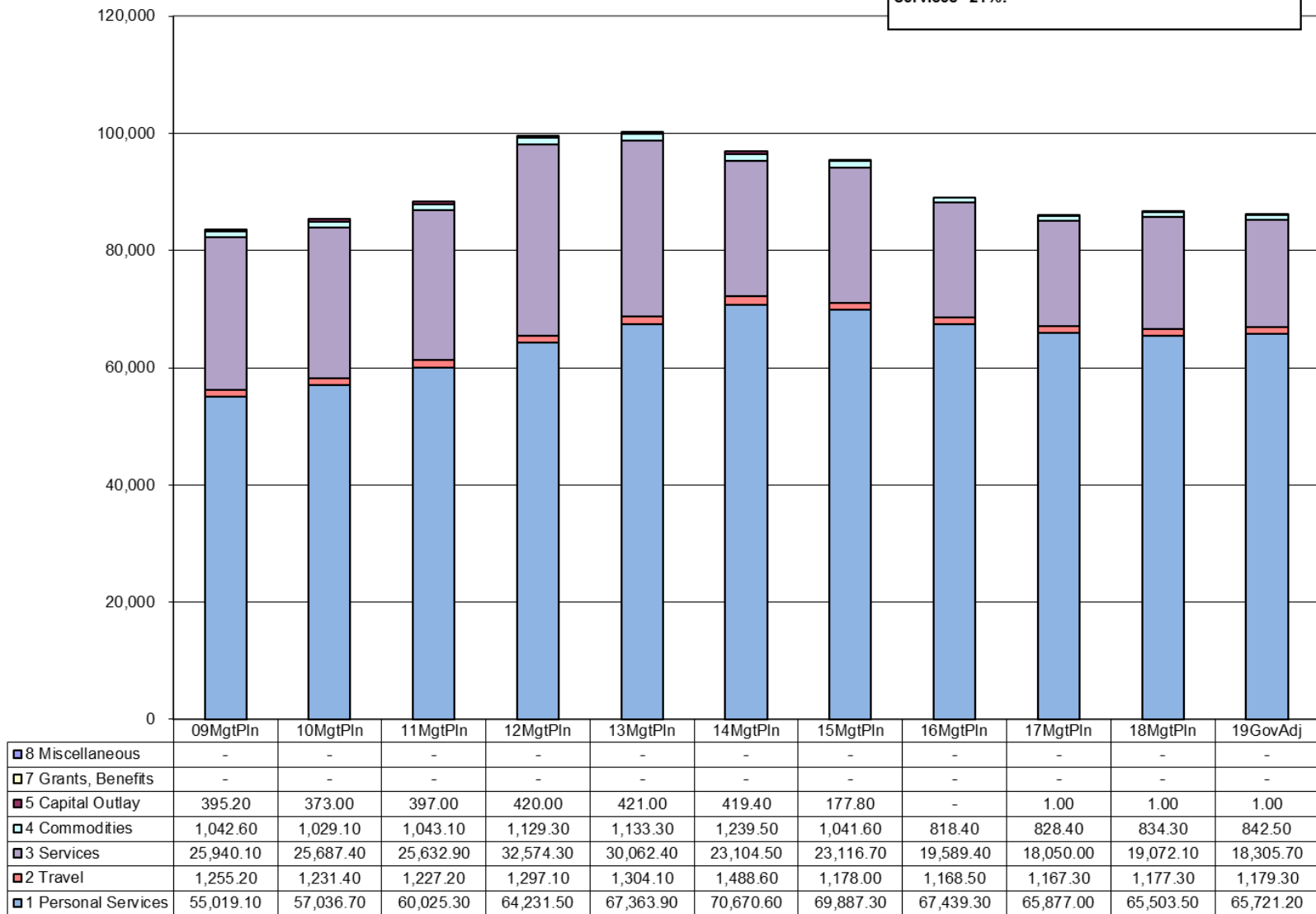

Services--21%.

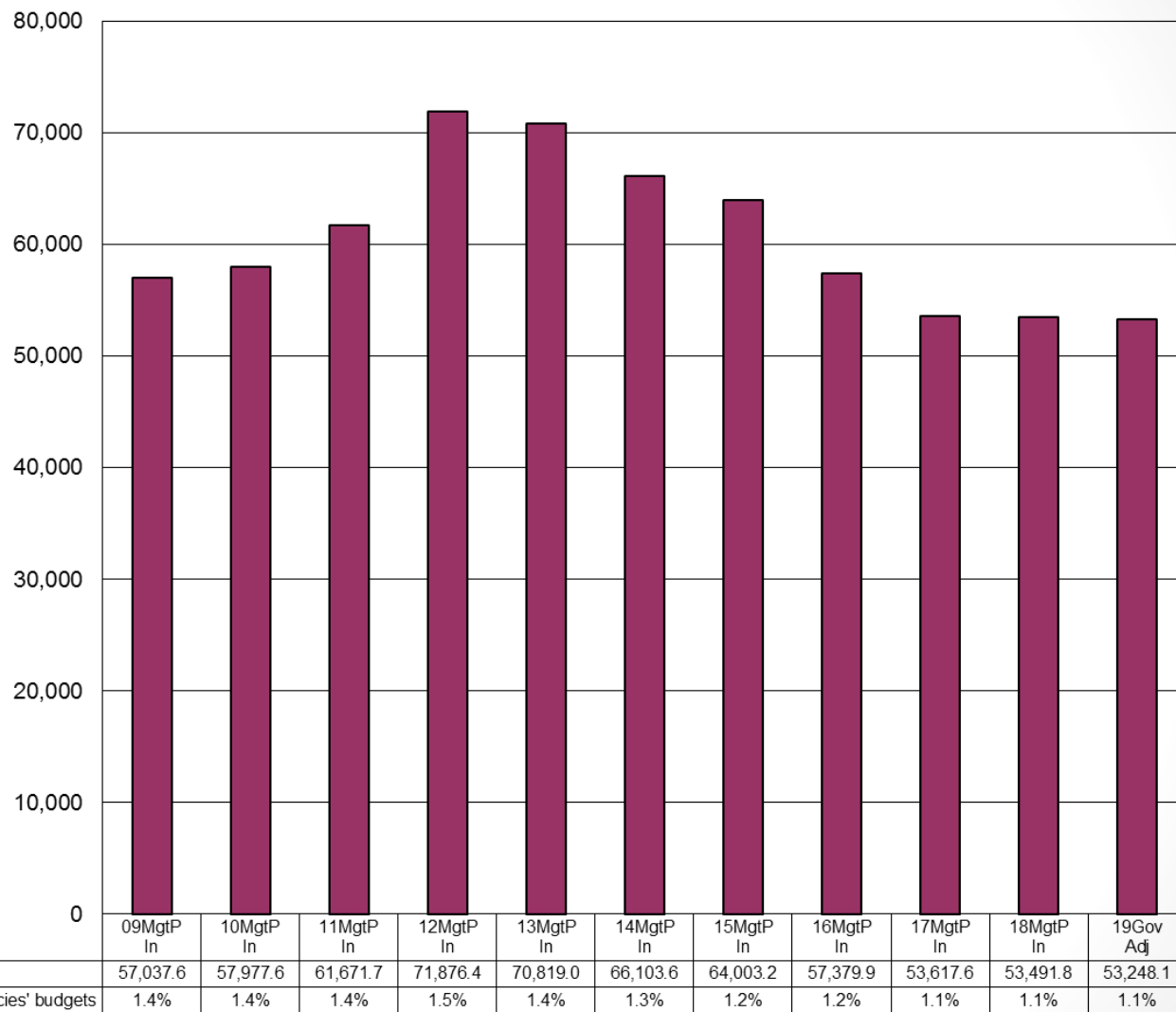

Department of Law's Share of Total Agency Operations (GF Only) (\$ Thousands)

The Department's GF budget decreased by \$3.8 million between FY09 and the FY19 Governor's Request -- an average annual growth rate of -0.7%.

The Department's total FY19 Governor's GF budget equals \$160 per resident worker.*



* According to the Department of Labor and Workforce Development, there were 332,583 resident workers in Alaska in 2015.

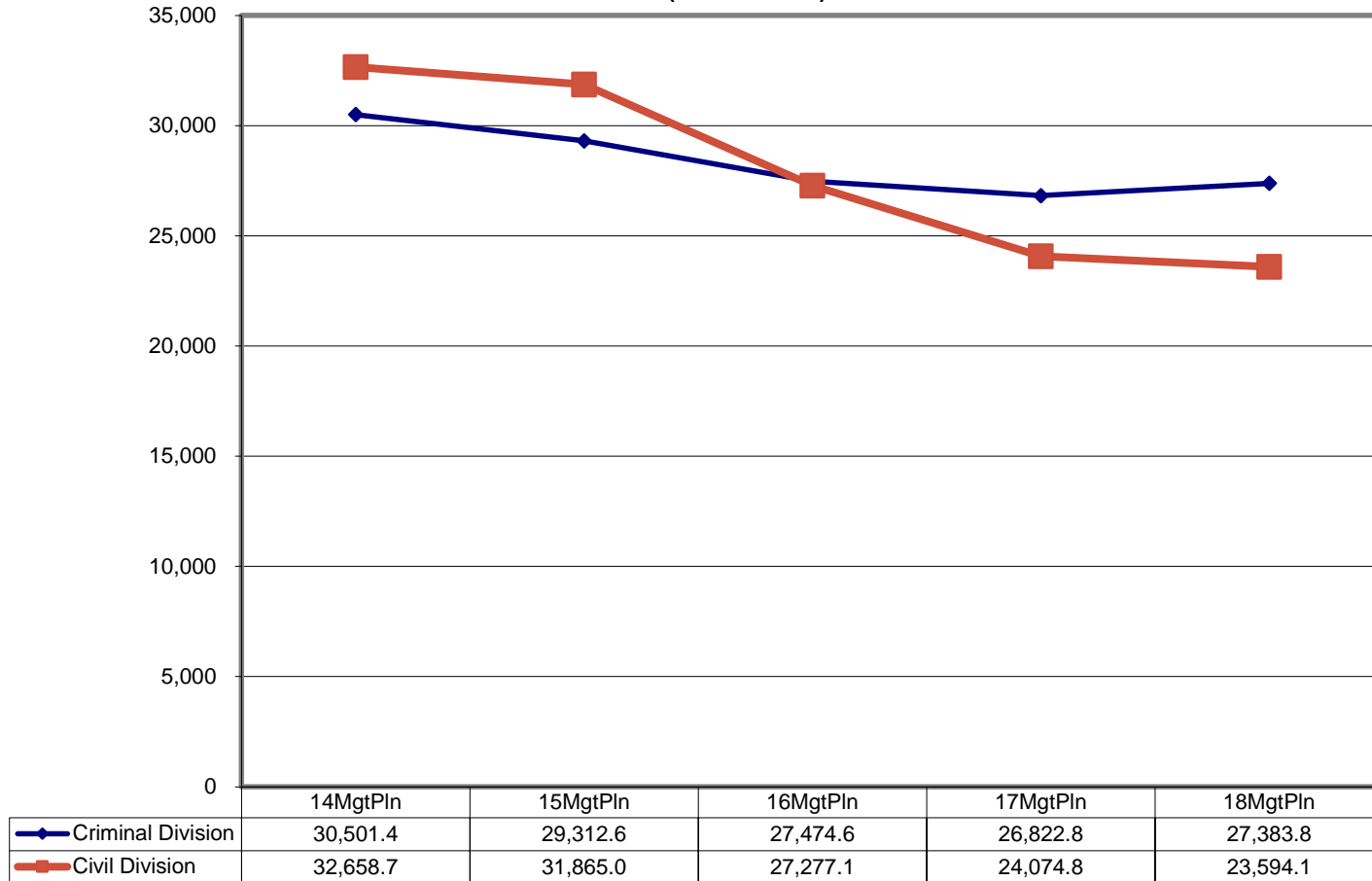

(\$ Thousands)



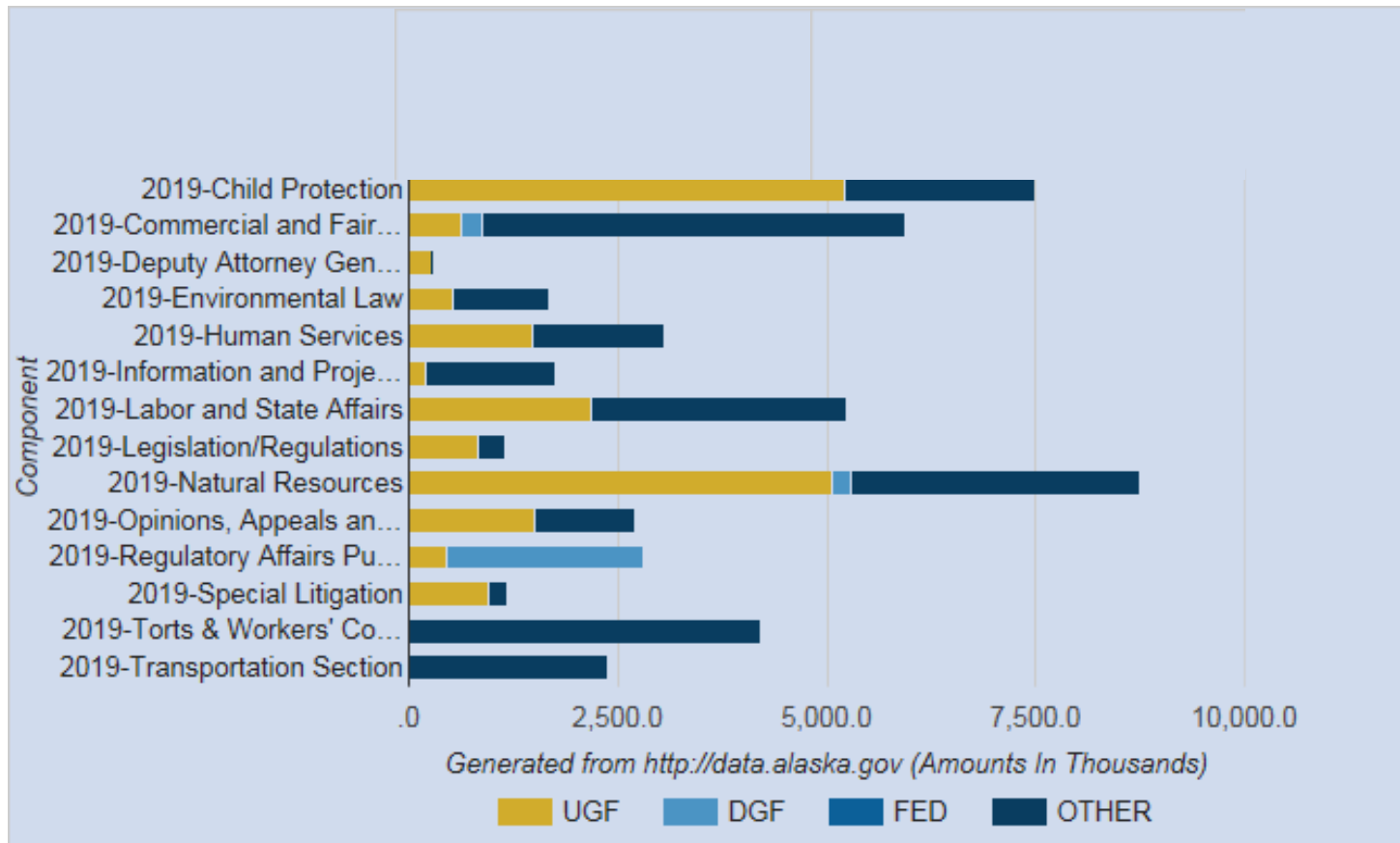

- Defends the state in federal and state appellate courts including Child in Need of Aid (CINA) appeals

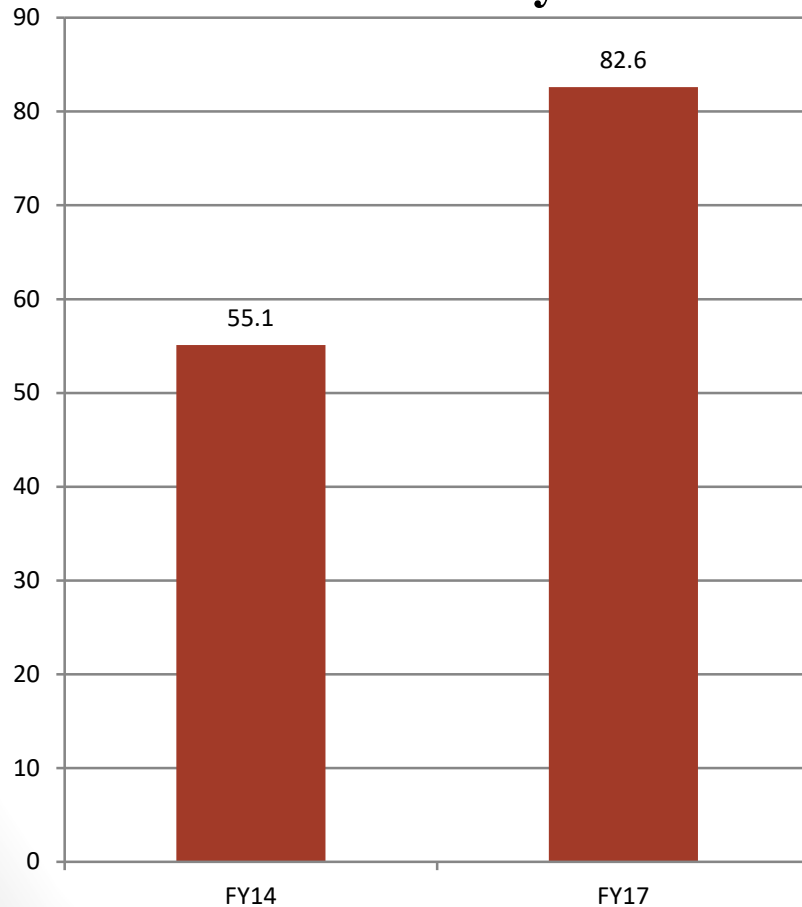

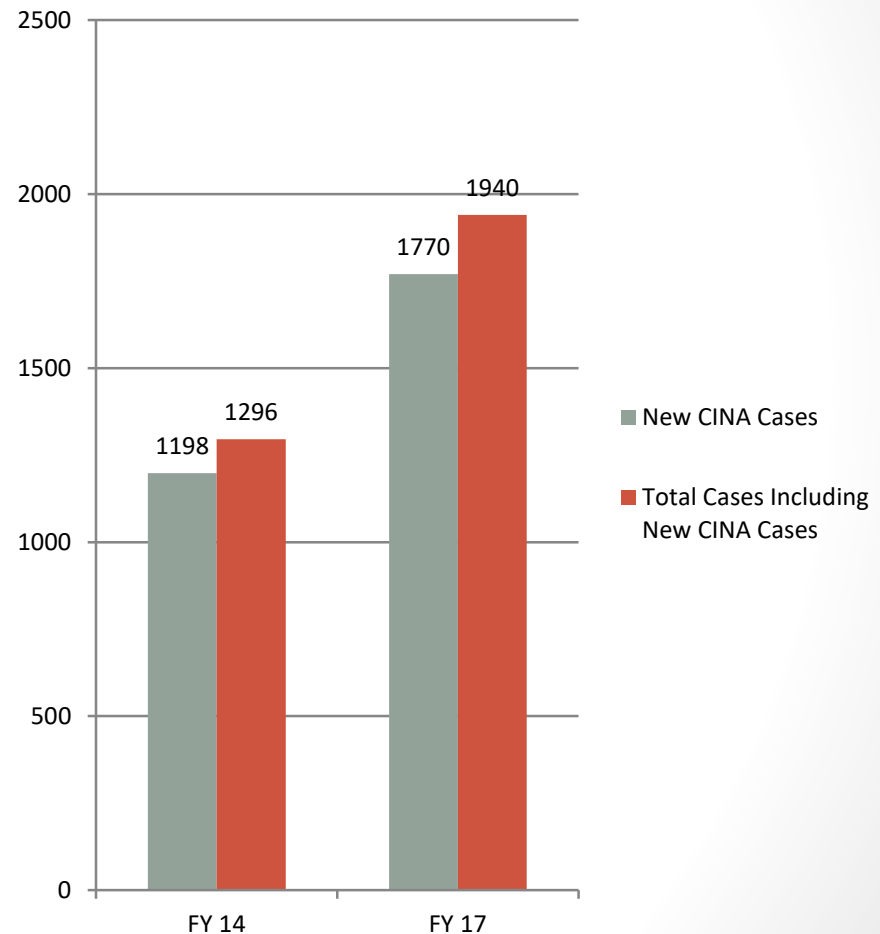

- Protects the state's fiscal interests in pipeline tariff proceedings before the FERC and the Regulatory Commission of Alaska (RCA), and protects Alaskan consumer interests in public utility proceedings before the RCA

- Handles high-profile, expedited and complex litigation, including constitutional challenges and elections matters

- Represents the Department of Transportation & Public Facilities on the construction and operation of public facilities, and major development projects across the state



Torts and Workers' Compensation (16 attorneys)

- Provides advice and defense to state agencies and employees in tort suits, and defends the state as an employer in workers' compensation claims

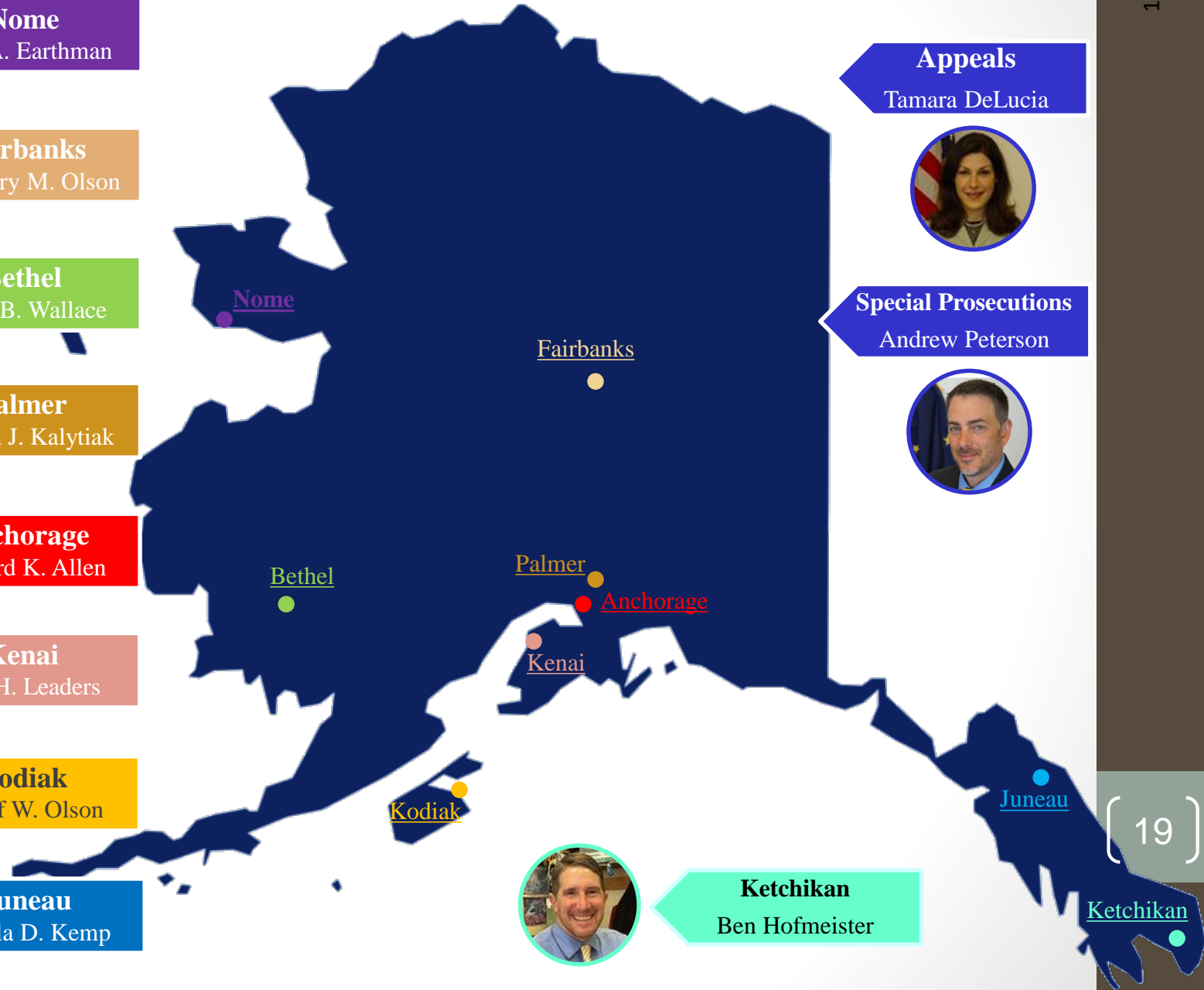

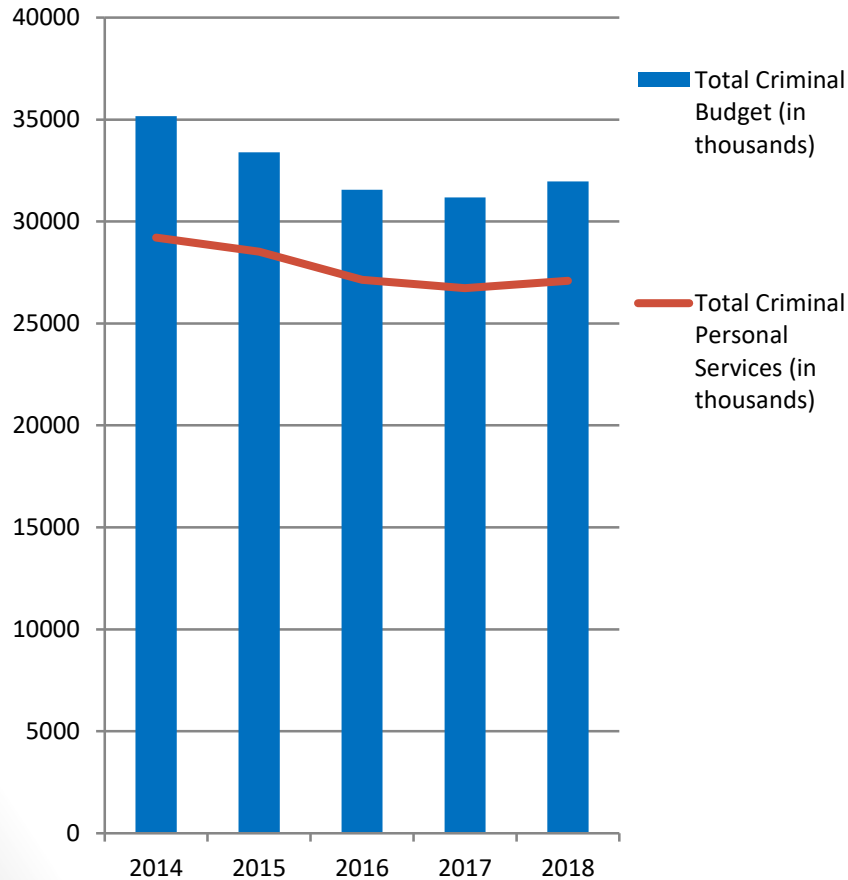

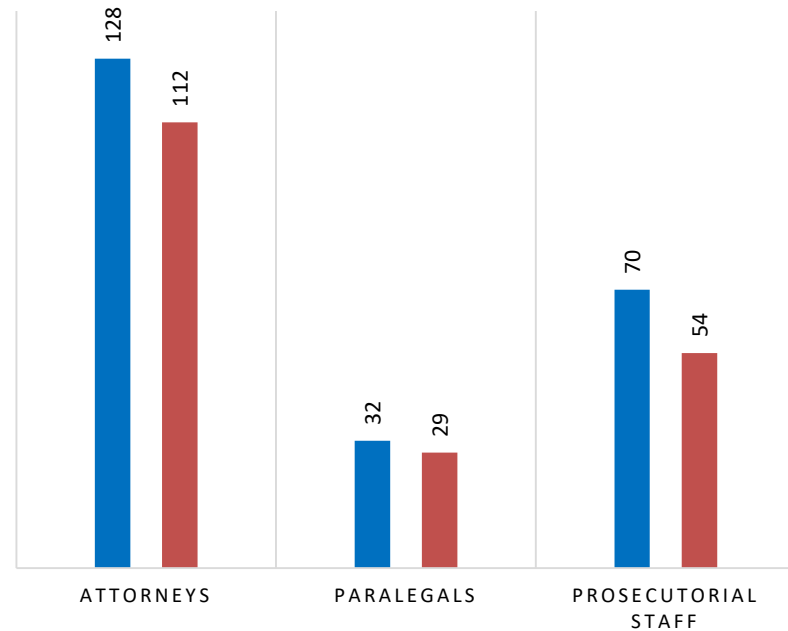
FY14-FY18 Criminal Division Total Budget vs. Personal Services Only

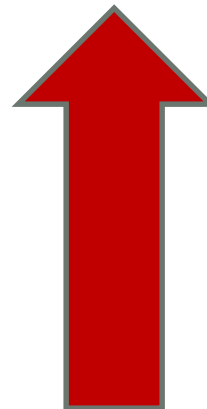

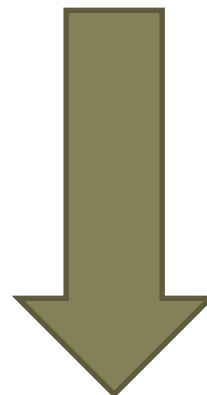
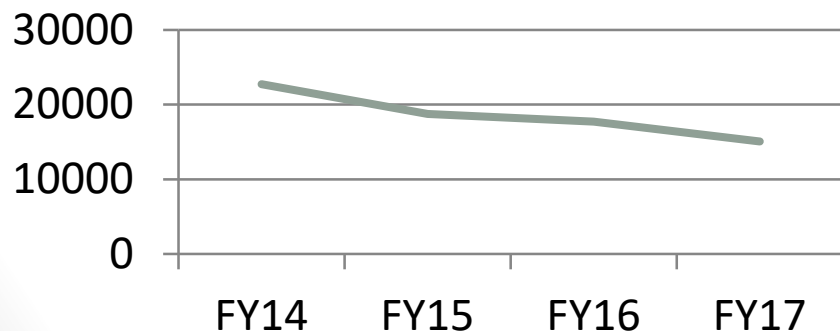
Felony Prosecutions

Changes in FY19

➤ Criminal Division: Implement the Public Safety Action Plan

- 1 prosecutor in Second Judicial District, Kotzebue: \$214.7
- 2 prosecutors and 2 support staff in Third Judicial District, Anchorage: \$473.1
- 1 prosecutor and 1 support staff in Fourth Judicial District, Bethel: \$310.5
- 1 prosecutor to act as the Statewide Drug Prosecutor in Anchorage: \$164.9
- Public Safety Action Plan implementation totals: 8 positions, \$1,163.2 UGF

➤ Criminal Division: Reduce SDPR in Second Judicial District, Utqiagvik

- Elimination of uncollectable Statutory Designated Program Receipt authority: (\$184.5)
- Budget authority is no longer necessary; the prior agreement with the North Slope Bureau expired

➤ Civil Division: Reduce Inter-State Pipeline Fund I/A receipts in RAPA

- Elimination of uncollectable ISPF I/A receipt authority: (\$138.6)
- Budget authority is no longer necessary as it is associated with a project no longer being pursued

➤ Administrative Services: Office of Information Technology Consolidation

- 7 positions moved from Law's Administrative Services component to the Department of Administration's Office of Information Technology (OIT)
- Line-item transfer from Personal Services to Contractual Services to accommodate RSA: \$766.6
