## FISCAL NOTE ANALYSIS

STATE OF ALASKA  
2018 LEGISLATIVE SESSION

BILL NO. SSSB 112

### Analysis

This bill sets out to reform or repeal and replace several statutes of the Workers' Compensation Act. Changes potentially impacting the Division of Risk Management (the Division) include reporting requirements for practitioners who prescribe controlled substances to patients in connection with an injury compensable through workers' compensation; changing retraining from a compulsory act to a voucher system controlled by the injured worker; and moving appeal hearings from the Workers Compensation Board to the Office of Administrative Hearings.

It is difficult to determine if any of these changes would financially impact the Division's Self-Insured workers' compensation program. The Division anticipates some changes have a potential to decrease costs while others could increase costs. The Division will absorb any impacts within existing budget authority.
