OFFICE OF HISTORY AND ARCHAEOLOGY

- **Serves as the State's Historic Preservation Agency**
- **Maintains statewide inventory of cultural resources**
- **Serves as the state liaison to federal agencies, representing the state's interests in protecting its heritage resources**

OFFICE OF BOATING SAFETY

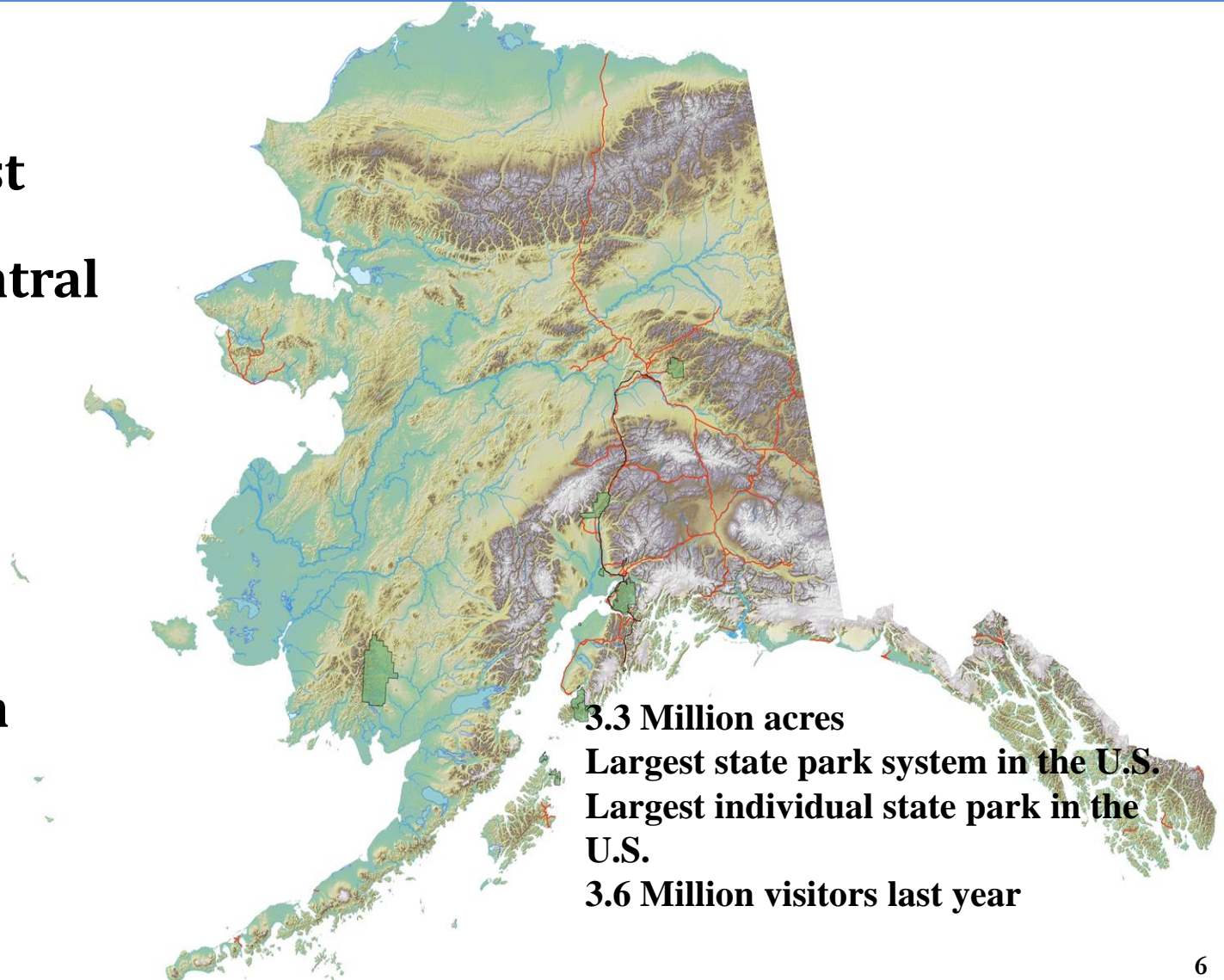
- **This year marks the 10,000th participant in the Kids Don't Float Program**
- **Staff Member Kelli Toth Received the prestigious National Boating Safety Educator of the Year Award**
- **At least 33 Alaskan lives have been saved by the use of a "Kids Don't Float" life jacket.**

FIELD OPERATIONS

- **Provides public safety and law enforcement in State Parks**
- **Works with 12 local citizen advisory boards that provide public input on park management**
- **Ensuring Alaska's State Parks provide high quality, sustainable park facilities that enhance the visitor experience**
- **An important partner of the state's visitor industry and community economic driver**
- **Park fees covered 51% of operations costs in FY17**

- **Chugach Region:**
 - **At 495,000 acres, the 4th largest state park in the U.S.**

 - **Wood Tikchik State Park falls under the management of the Chugach region**

REGIONAL POINTS OF INTEREST

- **Chugach Region:**
 - **At 495,000 acres, Chugach State Park is the 4th largest state park in the U.S.**
 - **Because of it's proximity to Anchorage, it sees high use**
 - **Joe Hall, Park Specialist was awarded a partnership award from the non-profit Alaska Geographic**
 - **Wood Tikchik State Park falls under the management of the Chugach region**

REGIONAL POINTS OF INTEREST

- **Kenai Region:**
 - **Kenai region park areas are some of the most diverse in the state, including:**
 - **Prince William Sound**
 - **Kachemak Bay State Park / Homer**
 - **Seward Parks**
 - **Kenai River Special Management Area**

REGIONAL POINTS OF INTEREST

- **Northern Area:**
 - Utilized federal highway funds to add significant improvements to Olnes Pond ATV Trail
 - Improvements / Riverbank stabilization at Big Delta Historic Park
 - Increase in fee stations and public use cabins
 - Delta Parks Permitted to private sector operators in FY18

REGIONAL POINTS OF INTEREST

- **Mat-Su – K'esugi Ken Campground:**
 - Denali State Park
 - 32 new RV / tent campsites with electric
 - 10 Walk in Campsites
 - 3 Public use cabins
 - Interpretive Pavilion
 - Partnership with the National Park Service

STATE HISTORICAL SITE ACCESS FEES

- **Independence Mine State Historic Park:**
 - Began charging historic access fees in 2017
 - April through September saw 43,000 visitors to the area
 - Rated number one attraction in Wasilla on Tripadvisor
- **Totem Bight State Historic Park:**
 - Began charging historic access fees in 2017
 - Summer 2017 saw over 45,000 visitors to the park
 - Rated the #4 recommended attraction in Ketchikan on Tripadvisor

PARKS AS ECONOMIC DRIVERS

- **626 Commercial use permits issued in 2017**
 - **Fishing guides, tour guide companies, water taxis, motor coach and van tours**
- **Visitor industry partnerships**
- **Adventure travel trends**

PUBLIC USE CABINS

- **Online reservation system implemented in 2017**
 - **No cost contract to the State**
 - **Allows ease in booking and payment**
- **Peak season occupancy rates for cabins exceed 85%**
- **Public use cabins have a payoff period of 3 to 5 years**



PARK SUSTAINABILITY

- **Increase number of fee areas**
- **Expand electronic fee options**
- **Statewide consistency in pricing**
- **Online booking for high use campgrounds**
- **Streamline permitting processes**
- **Increase partnerships with for profit organizations and non-profit supporters of State Parks**
