PDA Challenges

Workload Increases

- Overall workload continues to rise as increases in felony caseloads increase
 - 16% increase from FY17 to FY18 for felony cases Statewide
 - 18% increase from FY17 to FY18 for felony cases in Anchorage
- Civil cases increased dramatically over the last 10 years
 - 43% increase from FY14 to FY15 in CINA cases Statewide
 - 60% increase from FY14 to FY15 in CINA cases in Anchorage
 - 28% increase in commitment matters from FY14 to FY18
- Caseload is beyond maximum ethical limit set by the American Bar Association

Meeting Constitutional Obligations


Reduced resources impact ability to:

- Respond to new Court of Appeals decision increasing PDA responsibility for client travel expenses
- Maintain effective presence in rural offices necessary to meet ethical and constitutional obligations


Recruitment

PDA Workload Trends: American Bar Association




PDA FY 18 Projected Workload: 1998 LEG Audit

PDA Accomplishments

- Expanding Holistic Justice Initiative, designed to assist clients with non-legal barriers to successful re-entry, utilizing lower-cost, non-attorney staff
 - Working with Alaska Legal Services Corporation and the University of Alaska, Anchorage, through a grant from the Mental Health Trust Authority, on a study of holistic defense
- Launch of AmeriCorps program at PDA, leveraging AmeriCorps members to assist with client services, through a grant from ServeAlaska.
- Initiation of transition to a new case management system, scheduled for implementation in FY19.
 - Will result in efficiencies and cost savings related to discovery exchange between PDA and the Department of Law
- Continued Technology Cost Reductions by transitioning additional physical servers to DOA maintained virtual servers
- Cost reductions from held vacancies, employee furloughs, & teleconferencing
