### Analysis

This bill removes cardiopulmonary resuscitation (CPR) from AS 14.30.360(a) as recommended content for physical health and personal safety instruction and adds a new section AS 14.30.363 that requires CPR be provided in public schools using curricula adopted by the Department of Education and Early Development (DEED) at grade levels determined by DEED.

DEED will develop regulations to guide local curriculum adoption in accordance with statute.

There is no fiscal impact to the Department of Education and Early Development as a result of this legislation.
