FCC's Universal Service Fund

1996 Communications Act: requires carriers that provide interstate telecommunications services to "contribute" to USF.

FCC must use money to subsidize universal service based on specific principles. Ex: consumers in rural areas "should have access to telecommunications and information services . . . that are reasonably comparable to those services provided in urban areas."

2023 Universal Service Fund Support for Alaska

Rural Health Care: \$221M

Alaska Plan: \$167M

E-rate: \$110M

Lifeline: \$11M



Potential Impacts of an Adverse Decision Alaska

USF could cease within 32 days of a negative decision

Alaska USF Support

- Total Alaska USF of \$509 million in 2023
 - Exceeds the total net income of all telcom providers in the state.
 - Many telecom providers would be unable to operate without an alternate source of funding.
- Companies would be forced to stop all capital spending, shut down some networks and smaller communities, and layoff large numbers of employees.
 - Many would file for bankruptcy. Some would not survive.

Existential Threat to Rural Alaska Networks

Rural networks would likely have to right size by

- Terminating unprofitable services (including rural wireless sites).
- Discontinuing service to schools and health care organizations.
- Shutting down many rural networks.
- Abandoning rural construction projects.
- Eliminating participation in BEAD projects.
- Terminating employees.
- Retreating to a service footprint mostly along the road system.

Remedies

- Potential for a seriously adverse decision is unknowable, but the consequences would be devastating for Alaska.
- Encourage Congressional Delegation to put legislative insurance policy in place before any Supreme Court decision.
- Imperative that SCOTUS understands the extensive damage its decision will do to Alaska.
- Amicus filings critical to this understanding.
