Commissioner Mike Navarre

As Commissioner of the Department of Commerce, Community and Economic Development, Mike Navarre oversees six divisions and seven corporate agencies. He serves on the boards of the Alaska Housing Finance Corporation, Alaska Marine Pilots, Alaska Industrial Development and Export Authority, Alaska Energy Authority, Alaska Railroad Corporation, and Alaska Seafood Marketing Institute. Commissioner Navarre also serves on the Climate Action for Alaska Leadership team and the Alaska Mariculture Task Force. He is an active member of the Kenai Peninsula Boy's and Girl's Club Board, the Kenai River Brown Bears Board and co-chairs the Arctic Power Board.

Commissioner Navarre came to the Department of Commerce, Community and Economic Development from Kenai Peninsula Borough where he served as mayor for the past six years, with responsibility for managing 11 departments, 200 employees and a \$120 million municipal budget. He twice served as President of the Alaska Conference of Mayors. Prior to his service as the mayor of the Kenai Peninsula Borough, he served Alaskans in the Alaska House of Representatives from 1985 - 1996 in several different roles, including House Majority Leader and Finance Committee chair, as well as serving on the Joint House/Senate Health Care Task Force, the Long Range Financial Planning Commission and the Finance Committee.

Commissioner Navarre is also directly involved in the general and financial management of several privately held businesses in Alaska.
