Background for HB16: campaign finance law in Alaska

Prepared by Sharman Haley, Alaska Move to Amend

Once upon a time, Alaska's Campaign Finance Law was one of the strictest in the country. In 1995, citizens were disgusted with the corruption in politics. We filed an initiative to strictly regulate campaign ethics and finances, including lowering the limits on individual campaign contributions from \$1000 to \$500. The legislature responded to the initiative call and stepped up to enact the new law.

The stated purpose of the new law was "to restore the public's trust in the electoral process and to foster good government." That was the very year that a major corruption scandal emerged in Alaska. Six legislators, known as the Corrupt Bastards Club, were ultimately indited for accepting bribes from Bill Allen of the oil field services company VECO.

Seven years later, the legislature took it upon themselves to raise the limits back up to \$1000. The people of Alaska were furious. We stepped up again and reinstated the \$500 limits through a citizens' initiative, which passed with overwhelming, 73% support. Voters said in effect we want the law to be strict: it protects our balance of power as voters and constituents. It limits the disproportionate influence and corrupting power of big money in our elections.

Come 2010, the Supreme Court ruling in Citizens United struck down provisions of the solidly bi-partisan federal Campaign Finance Act, holding that spending by SuperPACS could not be limited. The Alaska AG advised the Alaska Public Offices Commission to stop enforcing the corresponding section of Alaska's law. As a predictable result, between 2008 and 2020, unregulated independent expenditures increased from 3% to 36% of campaign spending in our state. Including the ballot measures, independent expenditure funds were from Outside donors This flood of big money into Alaska elections is a source of concern for Alaskans across the political spectrum.

The assault on Alaska's campaign finance law continues. Following guidance from the US. Supreme Court, the federal 9th Circuit Court decision in Thompson v Hebdon (Nov 2018) gutted Alaska's campaign finance law, declaring that our voter approved limits were unconstitutionally low. The Dunleavy administration failed to appeal the decision. The Alaska legislature and the Alaska Public Offices Commission both failed to act to correct the problems in the law. Consequently, in 2022 and 2024 there were no limits on contributions to candidates. The results of unlimited contributions are stark. For purposes of this analysis, Big Money is defined as anything that exceeds the proposed limits in HB16: \$2,000 to a candidate for House or Senate, \$4,000 to candidates for Governor and Lt. Governor, and \$5,000 to a party or group.

Between 2020 and 2022 (post *Thompson v Hebdon*), there was very little difference in total contributions directly to candidates, but the mix was different. Big Money was 12% of the direct contributions in 2020, and 99% of this was from the candidates themselves or their party, which is effectively unlimited under law. By contrast, in 2022 Big Money was 37% of the direct contributions; 71% of it was in the Governor's race; and 53% of the Big Money was from Outside.

The news media reported that, as of August 15, 2022, incumbent Mike Dunleavy had raised \$2 million from 3,885 donors for his campaign for Governor. More than one hundred of these were in amounts in excess of \$2,500, comprising more than 43% of the total. Five mega-donors contributed more than \$50,000 each. Nearly 30% of the \$2 million was from out of state. Bill Walker raised nearly \$1 million, from 5,343 donors, with ten at \$2,500 or above, and 5% from out of state. Les Gara raised less than \$38,000, from 221 donors, with none more than \$2,000, and only 1% from out of state. (Data compiled by FollowTheMoney.org).

Without campaign finance limits, Big Money dominates and leaves the vast majority of constituents without equal representation.

What next?

Now again, citizens are stepping up to fix the problem. We collected signatures for a citizen's initiative to update the law, which will appear on the 2026 ballot. But we hope that you, the legislature will, as you did thirty years ago, step up and pass the new law this session. HB16 has the same language as the citizen's initiative. Your constituents call on you to act.

Dear Members of the House State Affairs Committee:

I am writing in support of passage of House Bill 16, without amendment in your committee. My name is Kevin Morford, and I am the president of Alaska Move to Amend, which is a non-profit grass roots NGO which advocates for improvements in public policy and election law. Our organization does not have any paid staffers, and relies entirely upon concerned Alaskans like myself to carry out its work.

As you may already be aware, Alaska had strong campaign finance limits in place for most of its existence as a State. The people of Alaska directly enacted those limits on a couple of occasions through the initiative process. A few years ago, the Ninth Circuit Court of Appeals struck down those limits in the court case of Thompson v. Hebdon. Since then, Alaska has not had ANY campaign finance limits in place.

After two years of inaction on this issue by the Alaska Legislature, the people of Alaska have once again stepped in to place a new initiative proposition on the ballot to reinstate reasonable and constitutional campaign finance limits on the ballot. That initiative will be voted on by the people in the state wide primary election in August of 2026. But the Legislature has the opportunity to enact this proposition into law in the current legislative session, through the passage of HB 16, which is substantively the same as the initiative language. I and my organization strongly urge the Legislature to do this.

If the Legislature passes HB 16 this session, then campaign finance limits will be in place during the 2026 election. If it does not act then there will be no campaign finance limits in place for that election. HB 16 is carefully crafted to survive constitutional challenge, and to be a fair and even handed limit on campaign expenditures. Please take up this important bill at your earliest opportunity, and pass it out of committee without amendment, so that it can be voted on by the entire House. Thank you.
