Dear Representative Claman and members of House Judiciary Committee:

I am writing in support of HB75- Gun Violence Protective Orders. Like most people, I am horrified by the mass shootings happening across the country. Every morning, when I drop my daughter off at school I wonder if there will be a shooter there. These fears have only been reinforced this week. I try to push it out of my mind and assume she will be ok, but in reality, the only thing being proactively done are drills at school to teach her to throw things at an intruder. We know this is not effective. Nothing gives me comfort that it won't happen here. Alaska has the highest rate of gun deaths per capita in the country and the highest rate of domestic violence. This is unacceptable to me as an Alaskan - and as a mother.

Fortunately, you are in a position to do something and there is an existing bill to consider. Please pass this legislation which would empower people closest to someone who may be expressing violent tendencies to report them to law enforcement and remove their access to guns. There is abounding evidence that restricted access to guns reduces gun violence- and saves lives. We have been asked if we see something to say something. This is one small step our state can take to keep our kids a little safer.

This will be a powerful tool to reduce gun violence as well as suicide. Please give families and law enforcement to ability to remove firearms from someone until they are no longer a threat to themselves or our community.

I hope you will hold a hearing on this bill and pass it this session. Thank you.

The time for conversations, many conversations, about reasonable gun legislation is now. Right now when 58 people have been murdered and over 500 wounded. The time was before this when the Pulse nightclub massacre happened. The time was when over 20 school children were murdered in their classroom with gun violence. The time was the Columbine shootings. Each time gun nuts say "This is not the time!" because it is very much the time and they don't want gun laws to change. The NRA is wholly unreasonable in it's opposition to any kind of gun legislation. There is an amendment (the Dickey Amendment) to prevent gun violence being studied by the CDC! This is so the American people will not know the full extent of the death, damage and potential damage of allowing the current permissive gun

laws to stand. The NRA campaigns ferociously to keep America ignorant of the damage they and lax gun laws do. People are calling them a terrorist organization. The NRA has brought a great deal of influence to bear on who gets elected in America with campaign contributions. After the mass shooting in Las Vegas Sunday all of America is asking why we can't have working gun laws, or indeed reasonable gun legislation of any kind! Other countries do not have the same amount of sheer, out-and-out mass gun murders as America. There is NO NEED for high-capacity magazines. There is NO NEED for semi-assault rifles. There is NO NEED for bump stocks. Why does the Dickey Amendment, which prevents the CDC from studying this kind of injury and death, exist? The NRA is indirectly and perhaps directly responsible for these many recurring mass shootings and gun violence deaths and the fact that the CDC cannot even study gun violence, which is truly ridiculous and to me seems criminal. Here in Alaska we think of ourselves as responsible gun owners, and we are proud of this. Most of the country (by poll) wants reasonable gun laws and Alaskans are no exception. People who say any gun control is a violation of our second amendment rights are simply incorrect. The Founding Fathers never envisioned anything like the weapons we have today, and they never envisioned a government so uncaring about individual citizen's lives as to allow them to be mowed down in a crowd by a madman with a semi-automatic weapon. Please enact legislation outlawing semi-automatic weapons, high-capacity magazines and bump stocks. Please do whatever is necessary to allow the CDC to study the gun violence that effects us all.

In the 20 years since the Columbine High School shooting "Thoughts and prayers" have proven to be useless in preventing nearly 400 school shootings. It is time for states to take action and protect our children from gun violence.

The first step in protecting the innocent from being the next victims of gun violence is to make sure those who pose a threat are unable to access a gun. Sadly, Alaska has one of the highest rates of domestic violence in the nation, and women are killed by husband/boyfriend/ex'es at an alarming rate. We can do something to lower our death rate and making women safer by ensuring that their abusers can't go into any store and buy a gun.

This bill isn't the answer to all gun problems. As gun law critics like to say, "if they want to kill someone they will." This may be true. Dear Legislator

I am writing in strong support of HB 75 to establish Gun Violence Protective Orders in Alaska and commend your efforts to prevent future violence. In light of the tragic school shooting in Parkland, Florida and the rising number of shootings and suicides in our own state and throughout the country, I believe that we must do all we can to empower family members and others to know the signs of gun violence and then act to say something to save lives.

Since the shooting at Sandy Hook Elementary and those that have followed, we have learned that the vast majority of mass shooters show signs of their intentions before becoming violent. That's why Sandy Hook Promise works within schools and community organizations, including in Alaska, to teach children and adults to know the signs of people who may be at risk of hurting themselves or others. By knowing the signs and acting, we can get others the help they need and save lives.

Gun Violence Protective Orders are a critical tool to preventing gun violence before it happens because they empower families to intervene when they see the signs of violent behavior and a person in crisis. GVPOs mirror the same, effective judicial process of domestic violence and civil protection orders. When there is documented evidence that a person is threatening to harm themselves or others, families and law enforcement can petition a court to temporarily suspend that person's access to firearms.

As the rates of mass shootings and suicides in this country continue to rise, GVPOs have proven to be effective at separating at risk individuals from their firearms and saving hundreds of lives.

In 1999, Connecticut became the first state in the country to pass a law granting law enforcement the clear legal authority to temporarily remove firearms from individuals when there is probable cause to believe they are at a significant risk of harm to self or others. A study on the effects of this law found that for every 10 or 11 guns seized through the restraining order, at least one suicide was prevented. Since Connecticut passed its law, states for across the country have started adopting this important policy, including Indiana, California, and Washington.

GVPOs also create safer circumstances for at-risk individuals to seek treatment, counseling or other resources to help address the causes of the dangerous and threatening behaviors. Passage of HB 75 would help build a system of prevention and care that will help decrease the risk of suicide and violence for Alaskans and their families.

I am proud to support HB 75 and I urge its swift passage. Thank you for your commitment to keeping our communities safe and preventing gun violence before it happens.

It is known that in states that have these kinds of laws, firearm-related domestic violence deaths have been reduced, and there is evidence that this kind of protection reduces the incidence of suicide. Alaska suffers from high rates of suicide and domestic violence and would thereby most notably reap benefits in these ways from this policy.

My name is Janice Swiderski, and I have been an Alaska resident for 22 years, currently in House District 28. I am respectful of the Second Amendment right to keep and bear arms, and I also strongly believe that common sense gun regulations go hand in hand with that right. We all deserve to live in a country where our right to life, liberty and the pursuit of happiness is also protected. HR 75 is one of those common sense solutions that can help protect the safety and security of all Alaska's citizens, without infringing on anyone's Second Amendment rights.

On a personal level, I am supportive of how HR 75 would help reduce the incidence of suicide by gun in our state. Many years ago my only uncle, my father's only sibling, shot and killed himself with a gun. I experienced the trauma that a

tragic suicide can bring to a family, and unfortunately, far too many Alaskan families experience this trauma now, at the second highest rate in the nation ,with Wyoming being in the #1 slot (at least this is my understanding from the most current data I could find).

Loved ones and law enforcement are often the first to see the warning signs when a person is in crisis. HR 75 would give them a way to protect that person from making an impulsive, deadly decision. Studies show that 90% of people who attempt suicide with a gun will die. In total contrast to that, 90% of people who attempt suicide by another method will survive, and the majority of those survivors do not make another attempt. Gun users are not more suicidal or have more intent, they simply have access to a particularly deadly method of self harm in a time of crisis.

Research also shows that variations in suicide rates across states are due primarily to variations in the availability of firearms, not by differences in mental health. And we are all very aware of the availability of firearms in a state where so many of us are gun owners.

I urge you to support this bill, to save lives and help insure that no family has to experience the tragedy my family did. I am writing today to express my support for your proposed bill, HB 75 – Gun Violence Protective Orders.

As Alaskans, we are all too aware of the epidemic of gun deaths by suicide in our beloved State, and across the nation. This bill would reduce the number of deaths by suicide by reducing a suicidal person's access to firearms. Nine out of ten suicide attempts with a gun result in death, whereas most attempts by other means do not result in death.

I wish this bill had been a State law in May of 2008, when a dear friend of mine, Nicklaus James Sorum, took his own life with a pistol. He was 21 years old. If HB 75 had been law, Nick's immediate family, law enforcement, or mental health professionals *could* have petitioned a court for an Extreme Risk Protection Order. The court *could* have reviewed the evidence and testimony of both parties (due process), and ultimately *could* have deemed Nick in immediate danger of harming himself or others, and required Nick to forfeit any firearms currently in his possession – even temporarily, and *could* have barred him from acquiring any new firearms. Nick's life *could* have been saved. No – there is no guarantee that this law would have saved his life, but isn't just the POSSIBILITY that it could have saved his life enough to justify it?

If this bill becomes law and prevents the death by suicide of even ONE person – ISN'T THAT ENOUGH TO JUSTIFY IT'S EXISTENCE?

Myself and many other Alaskans believe so.

Coinciding with our epidemic level of suicide deaths by firearm is the horrific frequency of mass shootings in our country. A nationwide study by Everytown for Gun Safety of mass shootings from 2009 to 2016 (available at: <http://every.tw/2BvFkXr>) revealed that in at least 42 percent of those incidents, there is documentation that the attacker exhibited dangerous warning signs before the mass-murder by firearm.

Once again, hitting close to home, Esteban Santiago – the alleged mass-murderer of the Fort Lauderdale airport shooting on January 6, 2017, was hospitalized briefly here in Anchorage in November 2016 for psychiatric care. He also had gone to the FBI office in town asking for help, telling the agents he was hearing voices and thought the government was controlling his mind (obvious symptoms of schizophrenia.) He HIMSELF relinquished the very firearm he used to kill 5 people and injure 6 more to authorities around this time, but those authorities had no method by which to withhold the firearm any longer once he decided to regain possession.

THIS IS NOT OK.

Again, the five lives senselessly lost to the murder carried out by someone exhibiting BLANTANT warning signs COULD have been saved if Alaska had a law like HB 75 in place at the time.

Rep. Tarr, I thank you, from the bottom of my heart, for championing this effort to SAVE ALASKAN LIVES. Myself and hundreds of other supporters are behind you 110%, and are praying that this Legislature wakes up and realizes that this bill has the potential to avert more senseless deaths by firearm.

I am writing to you as a registered nurse and as an Alaska resident of 25 years to voice my strong support of HB 75 (Gun Violence Protective Orders) to establish a "red flag law" in Alaska.

From my professional nursing experience, I know it is imperative to prevent individuals from obtaining or accessing firearms when they are at extreme risk of committing violence due to a mental or emotional crisis. Providing family members, medical professionals, and law enforcement officers with a means to accomplish this would save many lives. According to the Alaska Department of Health and Social Services, the overall suicide rate in Alaska is double that of the rest of the nation. The suicide rate is over three times higher among Alaska Native peoples. While not all suicide attempts are executed with a gun, most that result in death involve guns. A shot from a gun is immediate, irreversible, and fatal.

From a personal perspective, I wish to recount the story of my friend, a Persian Gulf War veteran. When he returned from the Middle East, he was diagnosed with PTSD and depression. He had difficulty sleeping due to nightmares and hypervigilance and he kept a loaded pistol under his pillow. He began abusing alcohol, street drugs, and his prescribed medications for anxiety and insomnia. During his most troubled years, he was involved in many physical fights and was arrested several times for discharging a gun while intoxicated. He never spent more than one night in jail and only the actual gun used in each offense was ever confiscated (temporarily). After each arrest, he returned home to a gun safe full of firearms. One night after drinking heavily and taking pills, he accidentally discharged one of his many guns, shooting himself in the leg, shattering his femur, and setting him on a path of repeated surgeries and compounded medical problems.

That injury was 100% preventable. The police, the court judges, his doctors, and his counselors at VA all knew he had substance abuse issues, mental health struggles, a history of violent behaviors, and guns in his home; but nothing was done – or could be done by law – to confiscate his vast collection of guns. He is fortunate to have not killed himself or someone else during that dark period of his life.

HB 75 will prevent injuries and save lives. Thank you for sponsoring this piece of legislation. I appreciate your ongoing commitment to ensuring the safety of our communities.

Dear Chair Claman and Members of the House Judiciary Committee:

Thank you for this opportunity to testify on HB 75, Extreme Risk Protective Orders.

We hope you will all support this common sense public safety legislation. It provides a needed tool for families and law enforcement to remove guns from individuals experiencing an elevated risk of endangering themselves or others.

We have seen all too many recent examples where the outcome of mass shootings might have been different had this tool been available. We cannot look away from the tragedy of those 17 students and staff in Florida. We cannot look away from five dead in Florida by an Alaska resident who reached out for help, but managed to board a plane with a gun in his luggage after Alaskan law enforcement had no legal authority to refrain from returning his gun. Most mass shooters have exhibited signs of their intentions before becoming violent.

Also heartbreaking is the prevalence of suicide in Alaska. It is likely that many of us in this room have been directly and personally affected by this, or at least have family and friends who have been. Providing a legal means of intervening with a person in crisis by removing his or her guns temporarily will give families a critical tool to protect their loved ones and prevent avoidable tragedies.

Oregon, Washington, Indiana, Connecticut and California have already established this type of protective orders, and 18 other states are considering such measures. This should be one area where we can come together in agreement to save lives.

We commend you for taking this up, and we urge your strong support for HB 75.

Dear Chair Claman and members of the committee,

Thank you to the House Judiciary Committee for taking our testimony. My name is Cheryl Lovegreen, and I am a resident of District 18 in Anchorage. I am writing as a member of Moms Demand Action for Gun Sense in Alaska.

Last weekend I was a judge for the State Drama Debate and Forensics Tournament. The last event I judged was Extemporaneous Commentary, where high school students describe and comment on political cartoons. The last two cartoons were about the recent school shooting in Florida.

One student, let's call her A, described going home the evening after the shooting, and being scared of that happening at her school. Her mother tried to comfort her, but had to admit she could not guarantee her safety. As A put it, "That's not okay." The other student, let's call her B, spoke about young people who are angry, lonely and afraid and don't know what to do with their negative emotions. She begged us to reach out and help those who might be at risk of becoming a shooter.

The good thing is, we have a chance to help these students and avoid more tragedies. We can pass HB 75. It will give people a way to help a family member in crisis - a gun violence protective order. A family member - or a law enforcement officer - seeing someone is at risk of doing serious harm to him or herself or others, can ask a court to find that the person is a danger to self or others. The court's order prevents that person from doing harm by ordering their guns to be temporarily surrendered and by preventing guns from being sold to them.. The bill provides relief in emergency situations while respecting due process.

Will this bill solve all our problems? Of course not—the situation is too complex for that. But it will give us one more tool in the toolbox and save lives. For example, a 2017 study of Connecticut’s Red Flag Law found that the law has already averted an estimated 72 or more suicides.

When I heard those students on Saturday, I felt like we failed them. But we can begin to address their fears and frustrations with this bill. It will provide a little hope to student A, B, and all the other young people out there. We owe it to them to do what we can. We must pass HB 75.

If you were to meet me you might never know I spent much of my childhood hoping that 'this' weekend when I went to my Dad's house he wouldn't be angry. That 'this' weekend he wouldn't be so depressed that he wouldn't get out of bed. That 'this' weekend I wouldn't end up crying in the kitchen as he explained to my siblings and me how he was going to shoot our mom and/or himself.

My Dad was bipolar. I was 8. Everyone knew he was sick. Everyone knew he didn't always take his medication. Everyone knew his three children were required to spend every weekend with him. Everyone knew he had a gun.

My Dad had a gun that he would bring out when especially manic and shoot off of our deck. This is when his children would have to convince him that killing mom wouldn't make his life better. My Dad had a gun he would shoot into the night when he was especially depressed. This is when his children would have to convince him that we did love him and his death would not make our lives better.

Thankfully, luckily, my Dad never used his gun on my mom or himself. Or us. But in those terror filled nights an 8 year old never knew if this was the night he would actually do it.

A gun didn't make my dad bipolar. However, it did make an already bad situation even more dangerous for him and his three kids. I implore the Alaska Legislature to support HB 75. By making sure those who are in crisis are unable to access a gun you are changing lives. By making sure those who are a danger to themselves or others aren't in possession of a gun you are keeping the next 8 year old from having to wonder how to keep a parent from using a gun on someone they love.
