Dear Members of the House Finance Committee,  
Governor Walker, Senator Gary Stephens and Representative Paul Seaton:

I write to you from Homer, where I am a mother of two teenage girls, a small business owner and operator, and an active volunteer in our community. I was born and raised in Alaska and came home to raise my family here.

**I ask you to support fully funding public school education.** I am the parent of two girls in public school here in Homer, at Homer Middle School and Homer High School. Alaskas public schools have cut to the bone, and I do not want to see teachers cut from public schools here in Homer or around the state. We can not cut teachers, and increase class sizes. We must prioritize public school funding. I received a great public education here in Alaska in the 70's and 80's and was proud to graduate from a blue ribbon public school. I am proud of the work our excellent teachers and educators do, and I do not want to see teachers pink slipped and funding cut. Please do all you can to support public schools, by fully funding and forward funding education. I also firmly oppose arming teacher, and I believe all guns and need to be kept OUT of the schools.

**I also ask you to support a broad based income tax.** Our family supports an income tax. We do not want to see education and social services cut. We ask for your support of a statewide income tax, and diversified revenue sources in order to support state education and critical programs.

**Lastly, our family supports all forms of common sense gun control.** I have contacted our congressional delegation in DC, but I understand that the state can take action to improve Alaskas gun control laws. Alaska has the highest rate of gun related deaths per capita in the country. My 15 year old daughter and about 150 of her classmates walked out of Homer High last week asking for safer schools and common sense gun controls. And my middle school daughter joined in a walkout at Homer Middle School. On behalf of our kids, I request the following:  
Ban Assault Weapons, and large capacity ammunition weapons  
Ban Bump Stocks  
Universal Background Checks  
Age Limits on Gun Purchases  
Waiting periods  
Extreme Risk Protective Orders.

Thank you for taking action to fully fund public education in Alaska. Thank you for working to implement a broad based income tax. And thank you for working to protect my girls, and all Alaskan by helping implement common sense gun controls.

A brief history before we get to our request. Sixty-two years ago the Mental Health Trust was created to provide care for Alaska's disabled. Government officials quickly squandered a billion or so Trust dollars in assets and in 1965 Alaska continued to ship many of the disabled out of state away from their families because care was cheaper for Alaska.

That brings the Mental Health Trust and the Alaska government to 2018. And the lack of bed space for disabled psychiatric patients, lack of proper care, lack of rights, and the intentional separation of patient and family.

Money has to be spent by the legislature on providing proper rights for the disabled including acute care psychiatric patients. Giving the disabled proper rights will finally force the state to provide proper care.

Alaska should pass a 14 page law similar to the state of Georgia '08 House Bill 535. Alaska to this day has not passed fair rights for the disabled and should do so.

Good morning, gentlemen -- I am writing as the school bus contractor for the Kenai Peninsula Borough School District. The folks at DOT here on the Kenai do a phenomenal job but are under-staffed, under-equipped, and I'm guessing under-budgeted for the equipment they do have, based on reports of equipment breakdowns.

We rely heavily on them to keep the bus routes clear and safe for our drivers and students. They respond to the best of their ability but clearly could use more resources and support.

My request to you is to responsibly fund AKDOT&PF, not continue to cut. My perception (worth exactly what you paid for it) is that cuts to local operations, i.e. an operator on the Kenai or not replacing a plow truck, are easy for you to make from Juneau and don't appear to have much of an impact.

You are wrong.

The cuts that continue to be made should be at the administrative and overhead levels, i.e. in Juneau, in personnel offices and extraneous expenses (travel, per diems, etc.) I will refrain from further political commentary on other cuts -- you have all heard from me personally with my opinions and in my professional capacity it is not appropriate!




I respectfully request you maintain the necessary funding for AKDOT&PF to allow us to continue safely bussing the students of the Kenai Peninsula.

**Subject:** Public Defender Funding

Dear Representative Seaton:

I am writing to urge the House Finance Committee to include full funding for the Public Defender's increment request to increase capacity in FY 2019, in response to the increased caseloads. I am a partner at Dillon & Findley, and Alaskan law firm, and have practiced law in Alaska for 19 years. I no longer practice criminal law, but began my career as a Public Defender. I am also a life-long Alaskan, and small business owner. I understand the need in tough times to reduce budgets. But, the far reaching impacts and hidden costs of failing to appropriately fund the Public Defenders are not justified. I am writing to urge funding that is crucial to protect constitutional rights. There is the very real constitutional crisis that will occur if caseloads increase at this level without any funding. A right to a fair trial is fundamental to the constitution, and is the right protected by appointed counsel. We cannot and should not be a state that fails to provide the basic constitutional protection afforded by the Sixth and Fourteenth Amendments guaranteeing a right to a fair trial. When you overburden the public defenders at the same time as you increase the prosecutors, you create an inherently unfair playing field that will result in injustice. Some of the core functions of representing a client suffer when caseloads expand at this rate like: 1) factual investigation into the underlying charges, 2) substantial trial delays, and 3) overcrowding in pretrial facilities waiting years to get a trial date. These hurt both victims and accused.

It will also result in litigation, and a lot of it. Wrongful convictions, hasty guilty pleas that are ripe for challenge, and post-conviction relief for ineffective assistance of counsel because a public defender was not capable of managing a staggeringly high case load are just a few of the areas. Wrongful conviction lawsuits alone can result in multi-million dollar verdicts against the state. The public relations nightmare caused by the Fairbanks Four will become common. The horror stories from states that have starved their Public Defenders agencies should not be Alaska's future. I strongly urge you and the Finance Committee to consider the hidden costs of underfunding an agency that is charged with protecting one of the most fundamental rights guaranteed by the constitutions.

RE: Letter in support for the operating budget amendment for increased federal authority through the Disproportionate Share Hospital program

Dear Representative Foster and Representative Seaton;

The Alaska Mental Health Board (AMHB) and the Advisory Board on Alcoholism and Drug Abuse (ABADA) are the state agencies statutorily-charged with advising the Governor and related Departments, and Legislature in the planning and coordinating of behavioral health services funded by the State of Alaska. The joint mission of AMHB/ABADA is to advocate for programs and services that serve people with behavioral health disorders, their families, care providers, and communities.

Our Boards believe there has long been a demonstrated need for additional acute behavioral health care services in Alaska. There are currently no residential facilities in Alaska for adults with acute mental health needs, leaving inpatient psychiatric emergency services, inpatient psychiatric hospitals, emergency departments, and inpatient general hospitals as the primary location for services.

We strongly support the operating budget amendment proposed by Representative Les Gara to utilize designated Alaska Comprehensive Health Insurance funds over the next three years to leverage additional federal authority through the Disproportionate Share Hospital (DSH) program. This funding will help hospitals offset uncompensated care costs to better respond to the increase in psychiatric emergency services for Alaskans who experience acute mental health and substance use disorder episodes.

Alaska's Psychiatric Institute (API) is currently at capacity and unable to serve the full mental health needs of Alaskans because of the limited number of beds. By allowing other hospitals and community behavioral health programs across Alaska to increase capacity through enhanced DSH funding, it will alleviate the immediate needs to provide the appropriate level of care to Alaskans experiencing a mental health crisis. Long-term solutions are already underway to increase

behavioral health treatment with the additional Certificates of Need and the Department of Health & Social Services' Section 1115 Behavioral Health Demonstration Waiver application. This amendment would reduce the existing burden on medical facilities in the short-term who are providing extremely costly beds and staff time while patients wait for the appropriate level of care to become available.

We understand the current fiscal climate is not conducive to additional budget requests. However, when you look at the system as a whole to provide the most effective treatment to people when and where they need it, we believe this solution will help solve the immediate needs of Alaskans and reduce the overall burden on our healthcare system.

Dear Co-Chair Seaton and Co-Chair Foster:

On behalf of the Prince William Sound Economic Development District board of directors and its members, I am writing about the \$23 million shortfall in operational funding for the Alaska Marine Highway System for state fiscal year 2018. It is our understanding that Governor Walker's supplemental funding request, embodied in House Bill 286, provides the necessary funding to ensure AMHS operations for the balance of SFY2018. We support the Governor's supplemental request and urge your support of the AMHS funding therein.

As you know, Prince William Sound communities and other coastal communities across the Gulf of Alaska are dependent upon the Alaska Marine Highway. AMHS ferry service provides access to roadless communities; facilitates economic activity in the tourism, seafood, and other industries; supports local businesses' operations; and is often the only alternative for shipment of durable goods into our most remote coastal communities. Residents, local businesses, contractors, and visitors rely on and plan around the ferry schedule, planning many months in advance to use the ferry for seasonal and year-round transportation and shipping.

It is also our understanding that a fast track bill may also be forthcoming. Please note that our commitment is to rational, full funding of the ferry system, not to any particular bill. We urge you and members of the House Finance Committee to ensure that the Alaska Marine Highway System has the necessary resources to fully operate throughout the current fiscal year and into the future.

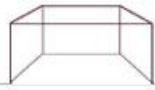
Thank you for your efforts. We recognize that the Legislature is grappling with many challenging issues and appreciate your attention to this matter.

On behalf of Museums Alaska, the statewide association of museum professionals, we strongly urge you to support continued funding of the Alaska State Museums' Grant-in-Aid (GIA) program, which Representative Dan Ortiz will be presenting to the House Finance Committee for a vote on Friday, February 23. This legislation is an amendment to HB 286.

Museums provide critical public services that help ensure community wellbeing and quality of life throughout Alaska. They preserve material culture, provide educational opportunities, and are venues for storytelling and cultural expression. As creative organizations, museums spur innovation and maximize and efficiently leverage their resources.

Most Alaskan museums are located in remote areas, work from limited budgets, and rely on grant funding for critical projects. Elimination of federal funding for museums (through IMLS) has been proposed by the current administration; loss of state GIA funding for museums would be devastating. This modest program has existed for 36 years and has helped many Alaskan museums preserve their collections, develop and update exhibitions, and professionalize. Museums without resources cannot adequately protect Alaska's cultural and historical heritage, so the loss of the GIA program would threaten Alaska's heritage statewide and our unique Alaskan story.

Museums are economic drivers. Seventy-six percent of all U.S. leisure travelers participate in cultural or heritage activities such as visiting museums. These travelers spend 60 percent more on average than other leisure travelers (Mandala Research, 2013). Alaska hosts over two million tourists annually, and a large proportion of these visitors actively seek out museums during their stays. U.S. museums return an average of five dollars to their respective state economies for every dollar in government money received (Americans for the Arts, 2015). Therefore, GIA funding should be considered an interest-bearing investment in the Alaskan economy as a whole. When times are challenging, museums are needed more than ever. They provide free and low-cost programming to members of the public of all ages. They provide opportunities to take in culture and beauty. They are places to learn, explore, and grow.

The Alaska State Museums were recognized earlier this year by the Institute of Museum and Library Services (IMLS) with a National Medal recognizing the museum's extraordinary and innovative approach to public service and community outreach. The GIA program is a key feature of this award-winning outreach.

We hope this letter has informed and helped convince you that the Alaska State Museums' Grant-In-Aid (GIA) program is a vital part of the social and cultural life of the communities it serves across the great state of Alaska.

RE: Disproportionate Share Hospital Funds in DHSS FY2019 Budget

Dear Representatives Foster and Seaton:

Please accept this letter of support for \$1.9 million included in the Alaska Department of Health & Social Services FY2019 budget proposal that will leverage an additional \$3.7 million in federal Disproportionate Share Hospital (DSH) funds. These funds would be used to provide services to Alaskans with acute and serious mental health needs, and to develop measures to address the impacts resulting from a shortage of mental health treatment beds at the Alaska Psychiatric Institute (API).

The closure of treatment beds at API resulting from renovations and staffing shortages has placed a greater strain on our already taxed emergency department (ED). We have had to notify the Municipality of Anchorage and Anchorage Police Department that we are not currently able to safely accept psychiatric patients. Historically, these types of specialty closures for psychiatric care rarely happened, now it is a weekly occurrence and it impacts the entire community. Our psychiatric ED remains full and last week we had an additional 10 psychiatric patients in the main ED.

By definition, emergency departments are safe places where patients can be held for court-ordered psychiatric evaluation or until a treatment bed opens at API. These stays are not only increasing in frequency, but duration. There are patients waiting up to 200 hours to be placed in API. When a psychiatric patient is held in the main ED, they require one-on-one supervision for their safety. This means nurses are being pulled from other patients and/or working overtime and it is further stressing the community's emergency care network.

We anticipate using any DSH funds to enhance and/or create strategies to address this growing impact on our ED and to continue providing care to Alaskans.
