Analysis

This legislation would create a new state department. The existing Division of Agriculture would be repositioned from the Department of Natural Resources (DNR) to become the new Department of Agriculture. The statutory responsibilities and authorities of the Division of Agriculture would not change; the bill makes changes to reflect the repositioning.
As the Division of Agriculture's budget would transfer from DNR to the new department, DNR's budget would be reduced by that amount. This note reflects the repositioning of the division's budget and personnel to the new Department of Agriculture.
This fiscal note is indeterminate pending committee discussion of the intent and structure of the new Department of Agriculture.
