



I have been a passionate leader in both tribal and public education in Alaska for over twenty-five years, and am confident that my experience and leadership will be an asset on the State Board of Education. I believe that cultural well-being and a strong indigenous identity, paired with excellent educational opportunities for every child in Alaska play an important role in the future of Alaska's communities. Meeting Alaska's Education Challenge will take committed leadership.

I bring to the Board a 28-year career in education in the state of Alaska, with 19 years in administration at both the school and district level in rural Alaska and the Fairbanks community. I hold a Master's in Educational Leadership from National University, Bachelor's degrees in Iñupiaq Language and English from UAF, and Principal and Superintendent's endorsements.
