I am writing in support of HB 16, which seeks to lower and set limits on campaign contributions in Alaska. As the hearings unfold, I want to share my perspective on why this bill is essential for the integrity of our political process.

- 1. **Restoring Reasonable Contribution Limits:** While I personally preferred the old \$500 contribution cap, I acknowledge that the courts have ruled otherwise. The current proposal offers a balanced approach that helps ensure no candidate—whether incumbent or challenger—is given an unfair advantage based on financial resources alone.
- 2. **Avoiding Favoritism Toward Incumbents:** I have considered the possibility that even lower contribution limits could inadvertently benefit incumbents. However, I believe HB 16 strikes a fair balance that doesn't overly favor either incumbents or challengers, especially in a world where deep-pocketed donors often have the final say.
- 3. **Ending the Influence of Dark Money:** One of the most concerning aspects of our current system is the way that "dark money" continues to obscure the true sources of campaign funding. HB 16 must ensure that all contributions are fully transparent, and that special interest groups can no longer launder money through opaque channels. This bill must prioritize accountability and transparency if it is to be truly effective.

Many of us who can only afford to make modest contributions recognize that the political landscape in Alaska is dominated by mega-donors and outside interests. Our voices are often lost in the noise created by the flood of money pouring into campaigns. HB 16 offers a chance to level the playing field, giving all Alaskans the ability to be heard over the clamor of money and influence.

Finally, I believe this bill will empower new candidates—those without access to the wealth of megadonors—to run for office. In many cases, it may be time for incumbents to face challenges and, in some cases, retire. A more balanced campaign finance system will allow more voices to be heard, ultimately making our democracy stronger and more representative.

I urge you to support HB 16. Change is overdue, and this bill represents an important step toward a fairer, more transparent political system in Alaska.


