RE: Senate Bill 204 Cert. of Fitness Plumbers / Electricians

Dear Senator Bjorkman and members of the Senate Labor & Commerce Committee,

Thank you for the time to review the proposed changes to the Certificate of Fitness for Plumbing and Electrical work in the State of Alaska. We have discussed Senate Bill 204 at length with our membership and are in support of the proposed changes. Setting the trainee license to 6 years not only will benefit the apprentice financially but will also cut down in the number of trainees whose licenses lapse. During the lapsed period trainees are not allowed to count their hours towards the requirement of 8,000 hours to take the State Journeyman test.

The increase from \$200.00 up to \$300.00 every two years, to the Journeyman license, has caused the most debate amongst our membership. The most common question I received was, what will we get for the increased cost?

We have asked for and supported additional inspectors for both plumbing and electrical work. It is our hope that the additional cost increase incurred by the Journeyman will go to keeping the bar high for these crafts by adding additional inspectors or other levels of enforcement. Having quality enforcement of these trades means we have equal standards for all employers to perform the work that requires a Certificate of Fitness. Plumbers and electricians are licensed in the State of Alaska because they perform work on systems that can cause serious harm, property damage, and death when improperly installed or serviced.

Keep in mind that these trades have the requirement to be licensed as the work being performed can and has caused serious harm and death when improperly done.
