## FISCAL NOTE ANALYSIS

**STATE OF ALASKA  
2024 LEGISLATIVE SESSION****Analysis**

This bill amends Alaska Statute (AS) 42.20 by adding a new subsection for emergency wireless telephone location disclosure. It requires the Department of Public Safety (DPS) to maintain a database of emergency contact information for wireless telephone providers to reduce delays in obtaining the current or most recent location of a wireless telephone in emergency situations. This bill codifies existing practice by law enforcement agencies and is not anticipated to have a significant impact to existing policies, procedures, or resources in the department, and the department is submitting a zero fiscal note at this time.
