Analysis

This bill authorizes the Department of Administration (DOA) to adopt regulations to provide for the electronic registral and titling of motor vehicles. It also authorizes the DOA Commissioner to enter into agreements with law enforcement agencies, governmental agencies or programs, and data exchange services. The bill does not remove the requirement drivers to have valid registration in their possession or in the vehicle. The bill also has a provision for when a peace of is presented with a mobile electronic device to display the electronic registration information, that the peace officer is immune from liability resulting from damage to the device unless the damage is a result the peace officer's intentional misconduct.	nt It for ficer s
While this bill will result in the public's ability to display registration and titling of motor vehicles in an electronic form the Department of Public Safety does not foresee a significant change to existing procedures when requesting and verifying motor vehicle registration and title information. As such, the department is submitting a zero fiscal note.	at,
