Dear Alaskan State Senate Committee Members and Chairman,

I am writing to you to tell you my testimony around S.B. 229. I am a School teacher, parent, and domestic abuse survivor. I waited over an hour and a half on the phone the other day to give my testimony, and was not called upon despite having waited so long. Allowing Committee members to leave during such an important bill is spiting the people that have elected them. Unless they're having a heart attack, or their family is injured in a car wreck, they should be doing their jobs that we elected them to do. A screen shot of how long I waited is attached

Speaking of which, I am greatly opposed to this bill. As a victim of domestic abuse where my wife constantly hit me, I am glad the state I was living in at the time didn't have these laws. She would have lied and signed whatever affidavit she needed to, to manipulate anyone who would listen to take my guns.

I am fundamentally opposed to this law because it breaks so many amendments to the U.S. Constitution that I don't know how you can not arrest the bill's sponsors, for dereliction of duty, since they're oath demands to uphold and protect the U.S. and Alaskan Constitutions.

First it breaks the second amendment as the right to bear arms is denied without a crime being committed.

Secondly, it violates the fourth amendment as it's illegal seizure of property. The standard of evidence is nothing more than a police officer's or family member's word.

Thirdly, it violates the 5th Amendment. The 5th Amendment clearly states that a person has a right to a speedy and public trial by a jury of our peers. This bill would replace the 5th Amendment with an ex parte hearing. Essentially a trial takes place, that I'm not at or even aware of. Then the punishment of having my guns confiscated comes before I'm even able to stand in front of my accusers.

The fourth amendment that it violates is the 8th. It is both an excessive fine (as most gun collections are at least several thousand dollars) and a cruel and unusual punishment to take someone's property when you haven't charged or convicted them with a crime.

Finally, taking the guns first, due process second is a massive denial of due process. A right delayed is a right denied. This inherently violates the 14th amendment due process.

As a school teacher, I know that kids in classrooms are sitting ducks for mass shootings. But we'll still be sitting ducks after this passes. Mass shootings stop when the second person with a gun arrives to stop the shooter. A smart criminal will simply keep their mouth shut so there'd be no reason to red flag them. If y'all had passed S.B. 127 and trained and allowed me to have my second amendment rights as a school teacher, you wouldn't have to worry about mass shootings.

Finally, as a parent, I don't want my children growing up in a world where there's no 5th amendment rights to stand before your accuser, where the constitution and individual liberty is nothing more than a mere legend of the past.

As I am sure you are aware, a Maryland resident is dead from refusing to give up his guns. He was shot dead by police. His wife later came out and said the accusation was false. This happened in Anne Arundel County, Maryland.

I'm sure you're also aware Indiana has so called Red Flag Laws. On July 22, 2022 a man came in with a rifle and started killing people. A concealed carrier, Elisjsha Dicken put the criminal down. Indiana's Red Flag Laws didn't stop this attempt.

I ask the committee to do your constitutionally sworn duty and kill this bill.

Senators and committee members, please find my written testimony on the SB229 Emergency Gun Violence Protective Orders as follows:

**Subject: SB229 an Emergency Gun Violence Protective Orders** by Senator Tobin, Gray-Jackson  
My name is Gary Kuhn, and I have been an AK resident for 66 years, and now reside in Palmer AK. I am a parent, grandparent, and great grandparent. I am representing myself.

First, I want to express my extreme disappointment for not be able to testify on May 30<sup>th</sup> because members of the committee decided to leave early and then the Chair and Bill sponsor unilaterally decided to eliminate the Alaska residents from testifying by shortening the meeting; I stayed on the phone for over an hour to be able to speak to this subject issue. That action on your part resulted in my voice on the subject has been curtailed or silenced by your insensitivity to a lack of commitment to hearing the public on these issues.

Some specific objections within SB229 are as follows:

**I Object to language:** "A peace officer or household member who reasonably believes that a person is a danger to self or others may file a petition under this" Bill.  
**I Object to language:** to the "the court shall ex parte and without notice to the respondent issue a protective order."

This language usurps "Due Process" and means that an accused has no say in their defense prior to a hearing, and this bill usurps that provision of our guaranteed citizen rights.

The US Constitution Bill of Rights Amendment IV assures that security of persons, houses papers, searches and seizures without due process. This bill usurps these protections and can and will be abused... This proposed language completely overturns the citizenry constitutional rights to be secure in their own domicile.

What we have here is a mental health crisis in the US not a gun access issue or gun violence issue. What we need to do is address this through strengthening the mental health laws, dealing with the drug crisis and stopping catch and release leftist practices. The mental health laws in Alaska have been lacking in substance and effectiveness for as long as I have been alive, yet no one wants to face those realities because it is hard. Well, I say take the hard road and address these Mental Health Issues now and stop this political wrangling that serves none of the Alaska citizens.

People have a propensity to blame the tool, or the gun for gun violence, rather than address the Mental health crisis and the potential violent perpetrator and their restoration back to normal mental, spiritual and physical health. Working on that mental health crisis problem and guns won't even come up in the conversation. Your job that you were sent to Juneau to do is to protect our already established rights, and

Dear Senators,

I have just today become aware of SB 229 and am very concerned with its provisions and possible unintended costly consequences. I am sending this email because testifying tomorrow is not an option for me.

Red Flag laws in general are seldom used in locations that have them, Chicago with more than 8500 shootings in roughly a two year time frame, saw the law used only four times. While proponents of Red Flag legislation will speak of saving lives and reducing injuries, how many injuries and lives lost might be caused from improper application of a Red Flag law due to some malicious intent? What are the consequences for people that use such malicious intent?

Domestic disputes and child custody disputes are known to cause people to act in vindictive ways, Red Flag laws could be abused. While law enforcement professionals are mostly very ethical, a few are not; could a Red Flag law create an avenue for bribery? Could a coworker that is upset with an individual cause grief? Could this law be used to intimidate a witness scheduled to testify in a trial? The answer to these questions is yes. And I have a personal story to support maliciousness by a coworker, and another story about being intimidated before testifying at a trial; in both cases my personal ownership of firearms was maliciously used in an attempt to harm me.

Another unintended consequence that is more prevalent in Alaska is the possibility of an individual being wrongfully disarmed and then being attacked by wildlife in the outdoors; pepper spray does not always work. But the most concerning is the costs that an individual could incur.

There have been a few instances of individuals having their firearms held by law enforcement and not returned in the original condition. After the long procedure to get them back, they have been sometimes returned damaged, sometimes "lost", and sometimes are "accidentally" destroyed. A close friend of mine had a \$25,000 irreplaceable firearm stolen, recovered by law enforcement, held through the trial, and then destroyed after the agency failed to return it to him.

The 24 hour surrender time in SB 229 is concerning. Many large firearms collectors would not be able to find a local dealer or dealers with enough purchasing power to buy collections. The immediate transfer of firearms falling under the NFA (machine guns, suppressors, destructive devices, AOW, SBR, and SBS) would to the best of my knowledge violate federal transfer laws, thus subjecting the item(s) to forfeiture without compensation and possible criminal penalties for both parties. Alaska has a very high percentage of firearm owners with NFA items, our state may in fact have the highest per capita in the nation.

While Red Flag laws are meant to save lives, do they effectively accomplish that task? A person that is suicidal has tools/methods other than a firearm at their disposal. A person that is determined to cause others harm also has other tools/methods at their disposal.

I am asking that you table this bill and place it in the trash can.
