I am Victoria Curran and have been a resident of Sitka for over 40 years. My life, like most people in Alaska has been sadly touched by gun suicide and homicide. As you know Alaska has the 2nd highest rate of gun suicide deaths and the 4th highest rate of gun deaths in the country. Guns are the most effective suicide method. Lawmakers should be doing everything they can to prevent this catastrophic violence. Currently over half of the U.S. population lives in a state with Extreme Risk laws. Let's join them! With 21 states and DC, including Florida and 5 other states with republican governors enacting Extreme Risk laws we are now able to use science to create effective policy. This is good governance. This science shows us that early intervention is the key to preventing gun suicide and school shootings. Family members and sometimes local law enforcement are the first to see warning signs when someone is in crisis that could pose a risk of gun violence to themselves or others. This is especially true in Alaska where our communities are small and close knit. Allowing family members or law enforcement to petition the court with evidence to obtain an order to separate guns temporarily from people at high risk has been proven to save lives. The science shows that at least 1 life is saved from suicide for every 10 ERPOs ordered . The ripple effect of just one gun death in our state is catastrophic – imagine what it would mean for individuals, families and communities if we could have prevented a dozen of these 125 gun suicides in Alaska last year. An ERPO can prevent mass shootings and school shootings as well – the benefit (humanity) of preventing even one would be immense. Please support SB229 – it is supported by good science and would be an effective policy. Thank you for the opportunity to testify.

I support the Extreme Risk Law for Alaska (HB 162/SB229) because I care about the lives of all Alaskans, especially those who are depressed, distressed, and hopeless. In 2014 my friend committed suicide with a gun. He felt at age 75 that life was no longer worth living, grabbed his gun and ended his life. If the handgun had not been readily available, if the family could have alerted authorities to the danger he was in and the gun removed, maybe he would still be here. I also worked with a youth program in Dillingham and arrived to work one morning to find a 16-year-old with access to a gun had killed himself the night before. An Extreme Risk Law might have been able to intervene to protect his life. Alaska has such a high rate of gun suicides. And Alaskans have readily available guns. I urge lawmakers to add one more tool to try and prevent the loss of life through suicide. Thank you!!!
