


ABOUT HILCORP

HILCORP IN SAN JUAN

- Hilcorp first entered the San Juan Basin of New Mexico and Colorado in 2017.
- Today, Hilcorp is the largest operator in the region.
- Hilcorp utilizes compact, state-of-the-art screw compressor packages to reduce output by 25,000 horsepower across the fleet, reducing emissions by over 80%.
- Hilcorp safely and effectively performed plugging & abandoning (P&A) operations on over 150 San Juan wells in 2022.
- Hilcorp invested over \$113 million into the state and local economies of the region in 2023.





- Hilcorp came to Louisiana in the early 1990's for the company's first acquisition and operation outside of Texas.
- Today, Hilcorp is the largest oil producer and one of the biggest gas producers in the state, with operations in 19 parishes.
- Hilcorp has been a leader in state-of-the-art plugging & abandoning (P&A) of retired wells, with more than \$28 million spent in 2022 to P&A over 100 Louisiana wells.
- Hilcorp invested more than \$232 million into the state and local economies of Louisiana in 2023.





HILCORP IN TEXAS

- Hilcorp was founded in Texas, and operates today in 35 counties across the Lone Star State. Hilcorp's corporate headquarters is located in Houston.
- Hilcorp operates some of the most famous and iconic oilfields in the state, including West Ranch, Tom O'Connor, Katy Field and Old Ocean.
- At West Ranch, Hilcorp launched a first-of-its-kind project using carbon dioxide (CO2) captured from coal plant emissions for Enhanced Oil Recovery (EOR), resulting in over 3.7 millions tons of CO2 being sequestered.
- Hilcorp has been a leader in state-of-the art plugging & abandoning (P&A) of retired wells, with over \$10 million spent in 2022 on P&A in Texas alone.





- Hilcorp invested more than \$30 million into the state and local economies of Wyoming in 2023.







HILCORP IN ALASKA

- Hilcorp is the biggest oil and gas operator, and the largest natural gas supplier in the state.
- Hilcorp first entered Alaska in 2011 as larger oil and gas producers were exiting Cook Inlet. In 2020, Hilcorp expanded to the North Slope's Prudhoe Bay in the company's largest acquisition.
- In 2024, Hilcorp made its largest ever budget commitment to future activities within Alaska.
- Hilcorp invested over \$1 billion in the Cook Inlet Basin and produced over 700 Bcf of gas since entering Alaska.
- Hilcorp partners with over 700 Alaska small businesses, service providers, and vendors.
