FISCAL NOTE ANALYSIS

STATE OF ALASKA 2025 LEGISLATIVE SESSION

Analysis

This legislation creates a new finfish farm permit program. The permit type described is similar to existing permits for aquatic farming. As a practical matter, finfish farming is aquatic farming. However, the bill is drafted to create new statutory framework and definitions for this activity. This approach creates a clear distinction between the two. This bill does not fundamentally change department programs. The Department of Fish and Game has systems in place to permit and manage aquatic farms and hatcheries that could be replicated for finfish farms, and the language in the bill gives commissioner of fish and game authority to establish regulations in consultation with the commissioner of environmental conservation to govern all aspects of finfish farming. Applications would be incorporated into the current process for similar permit types and receive the same level of scrutiny and review already conducted for existing permits. With existing permitting structures in place, the department can absorb the additional workload for processing applications for individuals or organizations that apply to engage in finfish farming. The department will also need to adopt regulations for the implementation of this bill but can absorb those associated costs. The bill provides for an application fee. However, the amount of the fee is anticipated to be zero while the department determines an average number of applications and the actual regulatory costs to permit this activity. Therefore, the department submits a zero fiscal note.
