Dear Senator Bishop,

The Alaska Municipal League (AML) is comprised of 165 incorporated cities and boroughs, local governments charged with providing essential public services. One of the building blocks of community development is fulfillment of the State's Constitutional obligation to maintain schools in Alaska.

While some in the State argue against increasing State revenues, AML members in August and November identified a mounting number of needs that would necessitate a State budget able to meet its obligations. In November, AML voted in favor of a broad-based tax. AML's 2019 position statement supports "investment in infrastructure and deferred maintenance."

Senate Bill 50 – the Alaska Education Facilities, Maintenance and Construction Tax – is one small step toward meeting the State's responsibility for maintaining public education, consistent with Article 7 of the Alaska Constitution.

We understand the intent to adjust the previous school head tax for inflation, from \$10 to \$30. We believe this is reasonable in its impact on local economies, but would also express concern that the net revenue to the State is insufficient to meet the needs of those school districts. We encourage consideration of an amount consistent with those needs as this bill undergoes the legislative process.

Local governments contribute significantly to school districts, in many cases well beyond their required local contribution. Many municipalities also contribute to construction and maintenance costs of schools. Municipalities have taken on roughly \$900 million in bond debt for school construction, and even with State reimbursement, the annual payments are important in terms of local budgets.

SB50 is a step in the right direction, and we commend the sponsor for following through on the State's commitment to education.

WHEREAS, Senate Bill 50 proposed to revise the repealed head tax on individuals, both resident and non-resident, with income from a source in Alaska; and

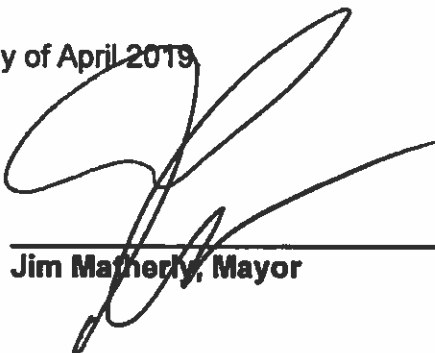
WHEREAS, according to statistics from the Alaska Department of Labor and Workforce Development and the U.S. Census Bureau, there are approximately 441,596 employed individuals in Alaska, and roughly 20% of those workers do not reside in the state; and

WHEREAS, it is estimated that the proposed \$30 per person tax would generate \$13 million each year; and

WHEREAS, under Senate Bill 50, the revenue collected would be deposited in the state's general fund and accounted for separately to pay for the growing maintenance and construction needs of Alaska's schools.

NOW, THEREFORE, BE IT RESOLVED that the Fairbanks City Council supports the passage of Senate Bill 50 and directs the City Clerk to distribute this signed resolution to Interior Alaska legislators.

WHEREAS, these new funds will be accounted for separately and used to pay for the growing maintenance and construction needs of Alaska's K-12 schools;

NOW, THEREFORE, BE IT RESOLVED, the Fairbanks North Star Borough Board of Education supports SB 50: Employment Tax for Education Facilities to address the capital needs of Alaska's schools, and encourages the Alaska Legislature and Governor Dunleavy to approve SB 50, as soon as possible.

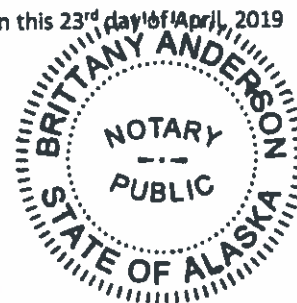

Honorable Senator Bishop:

On behalf of the Alaska Superintendents Association (ASA), thank you for sponsoring Senate Bill 50, the Alaska Education Facilities, Maintenance and Construction Tax. Our organization supports this bill and urges the Alaska State Legislature and Governor Mike Dunleavy to approve it as soon as possible.

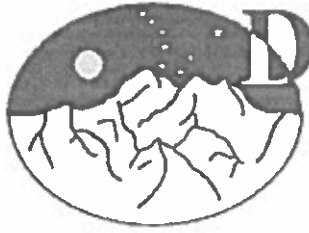
SB 50 makes a great deal of sense. Our organization carefully considered that working adults in Alaska used to pay a \$10 per head school tax for 60 years, until it was repealed in 1980. We believe that most working Alaskans would readily pay such a tax again if it were reinstated at the proposed \$30 per worker, adjusted for inflation. As a member organization of the Alaska Council of School Administrators, ASA embraces the highest priority in the Joint Position Statements adopted for 2019: Priority Funding for Education. This Joint Position Statement calls for, in part, “timely, reliable and predictable revenue for schools and a call for a Revenue Enhanced Fiscal Plan Imperative. This position statement notes that, “the need remains to finalize and implement a complete long-term multi-revenue fiscal plan that includes additional revenue streams.” We believe SB 50 aligns with both of these top two position statements.

In addition, results from a recent survey show that Alaska adults overwhelmingly support government funding for public K-12 schools, ranking them ahead of public health and human services, corrections, public safety and law enforcement, and higher education. This research was a collaborative effort of the organizations that make up the Alaska Council of School Administrators, and our partners at the Association of Alaska School Boards and the Coalition for Education Equity of Alaska. Released in February, the research also shows that Alaskans support elected officials who, in turn, support public K-12 education. 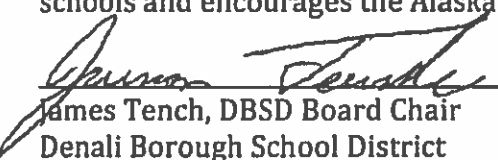

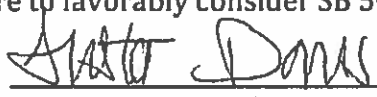
