FISCAL NOTE ANALYSIS

BILL NO. SB 114

Analysis

SB 114 requires that an in-state natural gas pipeline under AS 31.25.005(4) include a direct spur line to the City of Fairbanks and the Fairbanks North Star Borough. The Alaska Gasline Development Corporation (AGDC) ceased work on an in-state pipeline as defined by AS 31.25.005(4) in 2019.

This proposed legislation will not result in fiscal impact on AGDC or on the construction of the Alaska Liquefied Natural Gas project under AS 31.25.005(5), which is the integrated project consisting of North Slope Treatment Plant, pipeline, liquefaction, and export terminal in Nikiski.
