Page 1, line 9: Deleted "immediate and severe." and added "Increased" to better fit the tone of Resolution.

Page 1, line 10: Added "Southeast Alaska" to list of high-risk places.

Page 1, lines 13-15: Deleted "whereas" language.

Page 2, lines 7-8: Deleted "a demonstrated need for...additional" and added "community concern about there being sufficient...adoption of."

Page 2, line 10: Deleted "effective" and added "broad."

Page 2, line 11: Deleted "which could include expansion of public education programs" and added "engaging the public to learn about and take action through programs."

Page 2, line 12: Deleted "engaging residents in annual inspections and preparation through a program like."

Page 2, line 13: Deleted "coordinating" and added "and other local agencies."

Page 2, line 14: Deleted "other interagency coordination efforts" and added "agencies."

Page 2, lines 27-31: Deleted "; conducting full reviews of available response equipment, joint response agreements, ad water resources; identifying opportunities for additional water storage and access points; and inspecting and treating aircraft landing zones and roadways, especially those that are single-access routes to large." and added ", with special attention to single-access routes to isolated" to better encompass firefighting response goals.

Page 3, lines 5-10: Deleted "the Governor, the Department of Natural Resources, division of 6 forestry and fire protection, and relevant municipal and local agencies to expand public 7 outreach and education by implementing a statewide public awareness campaign on wildfire 8 risks and prevention strategies, which may include engaging residents and local fire 9 departments in a program like Firewise USA, inspections, and to be prepared for and evacuation preparedness using the; and promoting wildfire preparedness by launching an early detection campaign, promoting the program" and added "local and state public information officers, in collaboration 5 with state and federal agencies, to assist and encourage all Alaskans to learn about the potential for wildfires and changing exposure in their community including areas in designated Wildland Urban Interface (WUI) areas and to urge residents to learn about and take action to protect their homes and property through home defense programs including the Firewise USA program, and to be prepared for evacuation using the Ready, Set, Go! Program, and learn about and enroll in."
