## FISCAL NOTE ANALYSIS

### Analysis

This bill modifies the 2008 salary floor set out in AS 39.35.255, on which the Public Employees' Retirement System (PERS) employer contributions are based, for PERS municipalities that have sustained more than a 25% decrease in population between 2000 and 2010. The bill also allows the PERS Plan Administrator to determine the interest rate charged on delinquent payments to the PERS, which is currently a penalty rate of 12%.

This legislation will not have a financial impact on the Division of Retirement and Benefits to administer; therefore, the agency submits a zero fiscal note.
