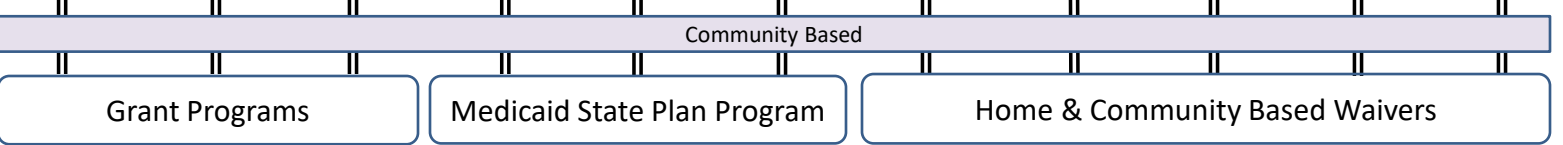

Each waiver offers a different set of services.
