FISCAL NOTE ANALYSIS

BILL NO. SB188

Analysis

This bill establishes payment to current nationally board certificated teachers and loan incentives intended to assist Alaska public school teachers seeking to earn national board certification.

Section 1 amends AS 14.20 by adding a new section, AS 14.20.225, Incentive and stipend payments for national board certification. This bill provides for annual payments to public school teachers who hold a valid national board certification. This includes a basic incentive payment of \$1,500 for teachers holding a current and valid national board certification and an additional \$1,000 for teachers holding this certification in high poverty attendance areas that have received a low performance rating as determined by the department. Additionally, for teachers seeking national board certification in a high poverty attendance area that have received a low performance rating as determined by the department, a school district shall pay the \$1,000 toward each teachers national board certification fees.

The base count for national board certified teachers is currently 150 plus an additional 25 teachers anticipated for FY2019 and each subsequent fiscal year. The maximum incentive provided under this legislation, if all teachers qualified for both incentives, would be 175 teachers x \$2,500 = \$437,500. Each subsequent fiscal year projects an additional 25 teachers receiving the incentives to reflect the anticipated annual growth (25 teachers x \$2,500 = \$62,500). This projection is contained in each subsequent year through FY2024.
