Dear Representative Drummond,

I am the Executive Director of Abused Women's Aid In Crisis, Inc. (AWAIC). I am writing to you regarding HB 214, 'An act renaming a portion of the Alaska Safe Children's Act as Bree's Law'.

ASCA was passed in 2015 and provided that a curriculum of healthy relationships, boundaries and dating relationships be created by participating school districts for grades kindergarten through twelfth grade. This act was passed to ensure that children and youth have the information to make healthy choices in life regarding their relationships with others. This is a critical step in stopping the cycle of violence in our communities.

A key piece of the curriculum is specifically about dating violence. AWAIC collaborates with the Anchorage School District by presenting to youth in the seventh and eighth grade. This part of the ASCA is taught at a critical age when youth are developing their first dating relationships. This message is reinforced throughout their high school curriculum.

Bree Moore never had someone come to her high school and talk to her about red flags of dating or the escalation of violence in abusive relationships which can lead to the victim's death, as in Bree's relationship. No one told her parents about what an abusive relationship looks like. They didn't know.

Women ages 16 to 24 experience the highest per capita rates of intimate violence.

The dating violence section of the ASCA curriculum speaks to the issues that Bree didn't get in high school and that her parents didn't hear about until it was too late. Bree Moore was murdered by her boyfriend on June 26, 2014.

AWAIC is advocating that the section about dating violence be renamed as Bree's Laws Program and Bree's Laws Activities. AWAIC feels this change humanizes this issue and this piece of the curriculum. It will incorporate the real life story of how one family learned about the harsh end of abusive relationships. AWAIC hopes that this recognition will be the personal message that will make an impact on Anchorage and Alaska students.

AWAIC supports the passage of HB 214.

Dear Legislators:

The Alaska Network on Domestic Violence and Sexual Assault offers our full support of efforts to rename the section of the Alaska Safe Children's Act that refers to teen dating violence awareness and prevention education to ***BREE'S LAW***.


We want to first acknowledge that the increased awareness at this time on dating violence results from, in large part, Bree Moore's death. We offer our deepest condolences to the Moore's for their loss. We further acknowledge the immense courage and perseverance the Moore's have harnessed in order to not only highlight the problem of youth violence, but to keep Bree's spirit and life visible so we all remain mindful: we can prevent violence.

Many take great pride in the rich natural resources in this State, but there are no resources more valuable, more precious, than our young people. Yet the statistics for safety and well-being for young people don't correspond with this value. For example, in 2015, Alaska was recognized as the most "dangerous state in America." Alaska leads in the nation as the state with the highest rates of gun deaths, domestic violence, and rape. For teen-specific data, consider key findings from the 2017 Youth Risk Behavior Survey:

- One in 10 students has experienced sexual violence (being forced by anyone to do sexual acts) during the past year;
- Bullying on school property has remained flat (23.3% in 2017), but electronic bullying (19.8%) has increased since 2011;
- There has been both a short- and long-term increase in the percentage of students who do not go to or from school because they feel unsafe at school or on their way to school (11.5% in 2017).

It is time for us to do more to safeguard our most precious resources. You have made a commitment to do so by first enacting the Alaska Safe Children's Act, and now recognizing the specific parts of the act that refers to teen dating violence awareness and education as **Bree's Law**.

No child should ever die as a result of violence: it is not right; it is not acceptable; it is devastating. Together, we can uphold a promise to young people that we will do our part as caring and conscientious adults to keep them safe and be responsible stewards of their development. It is no longer enough to say we can do this. We must do this. No child deserves to feel unsafe, to be bullied, to be harmed.

On Tuesday, February 20, Butch and Cindy Moore graciously presented Bree's story to the entire Steller student body. The presentation was impactful, moving, and motivating to our students and staff. We felt that the presentation was very humanizing and necessary considering the statistics in Alaska. Students are engaged in learning more about healthy relationships and the prevention of dating violence now that they can connect the consequences to a real person to which they relate. Students have voiced that they didn't understand what they were previously learning or why the school was covering the topic before the presentation by the Moore's. Students are now asking for more education on the topic and want to continue with the lessons taught last semester because they understand why the material is so important to learn and discuss. The students hope that the Moores present at other schools as well, because they think their story is really important for young people to hear.

The Steller staff and student body would like to support HB214 in its current state to name the education of relating to dating violence and abuse in the Alaska Safe Children's Act as Bree's Law for the following reasons:

- Students' connection to another relatable young person, the name on the bill, establishes an Alaskan story and a connection.
- Students' didn't understand what they were learning or why they were learning it before the presentation by the Moores. The appropriate name will lead to humanizing, and show significance of such a law.

My name is Rachel Curtiss. I am a senior at Steller Secondary School in Anchorage, Alaska. On Tuesday, February 20th, we saw a presentation by Butch and Cindy Moore, Bree Moore's parents. They told us about their daughter's life, jobs, relationships, and murder. There was not a student in that room who did not feel the weight of her death and the importance of the education. There was a power behind this presentation that cannot be found without the name attached to it. Earlier in the year, we did the first round of the Bree's Law education without hearing any of her story or even her name. Many of the students did not understand the value of the lesson, or the context of the story. During the presentation about Bree, every student payed rapt attention. I ask you, as a student who understands the value of this education, to vote to pass HB214 with Bree's name attached.

With Bree's name, the education becomes immediately more relatable and impactful to students. Just like the Amber Alert, Kendra's Law, and Megan's Law, the name allows us to look not only at the statistics, but at the effect of the education (or lack thereof) on a human level. I ask you to understand that there is power in Bree Moore and her story. I ask you to vote for the proper education of students so that they can avoid harmful relationships. I ask you to vote to pass HB214 as it is.



Dear Legislators:

Thank you for the opportunity to support this proposed legislation. Thank you to the bill sponsor, Representative Harriet Drummond.

Over the last twenty-five years, federal and state legislation has been passed in the name of a victim of crime as a memorial, while making drastic changes in response to violent crime. Multiple federal laws have mourning parents to thank for their advocacy on behalf of their murdered children:

- Jacob Wetterling Crimes Against Children and Sexually Violent Offender Registration Act (1994)
- Megan's Law (1996)
- Amber Alert (1996)
- Pam Lychner Sexual Offender Tracking and Identification Act (1996)
- The Adam Walsh Child Protection and Safety Act (2006)
- International Megan's Law (2016)

In 2015, Erin Merryn visited Alaska and shared her story of surviving years of childhood sexual abuse, urging members of the Alaska Legislature to pass a law requiring schools to provide information to all Alaska children about child sexual abuse, and what to do if it happened to them or someone they knew. It also advocated training for school staff, to know how to handle a disclosure of abuse from a child.

Concurrently, the Alaska Legislature was hearing advocacy from Butch and Cindy Moore, parents of Bree Moore, about including dating violence prevention education in high schools throughout Alaska. Breanna Moore was fatally shot by her boyfriend in 2014.

While Alaska eventually passed the combined legislation, it was implemented under another name, the Alaska Safe Children's Act, in 2017.
