WHEREAS, The Lake and Peninsula Borough imposes a tax on professional guides; and

WHEREAS, The it is the Borough's intent that the tax be accurately reported and taxes due; and

WHEREAS, The Borough intends the tax to be fairly applied; all guides that operate within the Borough's borders pay their tax due equitably; and

WHEREAS, The Borough needs to insure and verify the accuracy of self-reported guide activity to insure all tax due the Borough are paid; and

WHEREAS, The State of Alaska maintains hunting and sports fishing records that would if available to the Borough help the Borough in its duty to equitably enforce its tax code; and

WHEREAS, the Borough Code ensures confidentiality of all tax records and adherence to State laws concerning same.

NOW, THEREFORE BE IT RESOLVED, that the Lake and Peninsula Borough Assembly, by this resolution, resolves to express its support for and urge passage of House Bill 267.

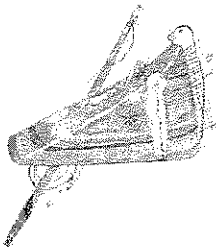

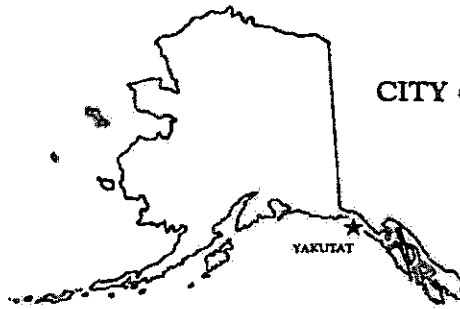

Speaker Edgmon,

The City and Borough of Yakutat supports the passage of HB 267 that gives municipalities affected, the access to guided hunt and guided sport fishing records for the purposes of verifying taxes payable to them.

As oil prices plummeted in recent years, the ability of the state to continue various state programs to assist communities around the state has been severely impacted. This is in addition to almost non-existent capital budgets over the same time period.

This has prompted municipalities such as ours to not only tighten our belts, but it is incumbent upon us to ensure our residents are fully compensated for the resources that are being harvested from our management areas or jurisdictions if you will.

To us it is a matter of fairness that we have access to these records to ensure compliance with our various ordinances. This will lead to additional revenues for a myriad of infrastructure needs in our towns and villages that the state can no longer afford to provide.

It is also a matter of fairness to the guides that are paying their fair share. By having these records we can level the playing field and capture significant revenue from those operators that have not paid their taxes due for one reason or another.

In addition, all records of this nature are strictly confidential and are punishable to the fullest extent of the law if violated.

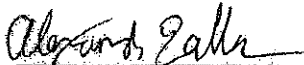
