7 registration. When filing an application for a new registration under this subsection,
8 the applicant shall submit the applicant's fingerprints and the fees required by the
9 Department of Public Safety under AS 12.62.160 for criminal justice information and
10 a national criminal history record check. When filing an application for renewal of
11 registration, an applicant shall submit the applicant's fingerprints and the fees
12 required by the Department of Public Safety under AS 12.62.160 for criminal
13 justice information and a national criminal history record check every five years.
14 The board shall forward the fingerprints and fees to the Department of Public Safety to
15 obtain a report of criminal justice information under AS 12.62 and a national criminal
16 history record check under AS 12.62.400."

15 classified, partially exempt, or exempt service under AS 39.25 for which regularly
16 assigned duties include handling or having access to vital statistics records, unless the

17 (1) individual submits to the hiring authority two full sets of the
18 individual's fingerprints; and

19 (2) hiring authority verifies that the Federal Bureau of Investigation
20 has, based on the fingerprints provided under (1) of this subsection,

21 (A) conducted a national criminal history record check of the
22 individual under AS 12.62.400(a); and

23 (B) advised that the individual has not been convicted of a

1 criminal offense of which the use or misuse of vital statistics records was an
2 element.

3 (b) Upon receipt of an individual's fingerprints under (a) of this section, the
4 hiring authority shall submit the fingerprints to the Department of Public Safety. The
5 Department of Public Safety shall submit the fingerprints to the Federal Bureau of
6 Investigation for a national criminal history record check under AS 12.62.400(a).

7 (c) Upon receipt of the results of the national criminal history record check
8 under (b) of this section, the Department of Public Safety shall advise the hiring
9 authority whether the individual has been convicted of a criminal offense of which the
10 use or misuse of vital statistics records was an element.

11 (d) In this section,

12 (1) "hiring authority" means a person with authority to hire or retain an
13 individual in a position in the classified, partially exempt, or exempt service under
14 AS 39.25;

15 (2) "vital statistics" has the meaning given in AS 18.50.950."

6 "* Sec. 2. AS 28.35.030(o) is amended to read:

7 (o) Upon request, the department shall review a driver's license revocation
8 imposed under (n)(3) of this section and

9 (1) may restore the driver's license if

10 (A) the license has been revoked for a period of at least 10
11 years;

12 (B) the person has not been convicted of a driving-related
13 criminal offense in the 10 years preceding the request for restoration of the
14 license [SINCE THE LICENSE WAS REVOKED]; and

15 (C) the person provides proof of financial responsibility;

16 (2) shall restore the driver's license if

17 (A) the person has been granted limited license privileges
18 under AS 28.15.201(g) and has successfully driven under that limited license
19 for three years without having the limited license privileges revoked;

20 (B) the person has successfully completed a court-ordered
21 treatment program under AS 28.35.028 or a rehabilitative treatment program
22 under AS 28.15.201(h);

23 (C) the person has not been convicted of a violation of

AS 28.35.030 or 28.35.032 or a similar law or ordinance of this or another jurisdiction since the license was revoked;

(D) the person is otherwise eligible to have the person's driving privileges restored as provided in AS 28.15.211; in an application under this subsection, a person whose license was revoked for a violation of AS 28.35.030(n) or 28.35.032(p) is not required to submit compliance as required under AS 28.35.030(h) or 28.35.032(l); and

(E) the person provides proof of financial responsibility."
