Planning Outline: House Resources 2018 Food Security Subcommittee

The House Resources Committee addressed several issues relating to food security during the 2nd session of the 30th Alaska Legislature. Additionally, the State's new Economic Strategy has several priorities related to these topics. Alaskans spend \$1.9 billion each year buying food produced outside the state, and supply disruptions threaten our food security, so even small changes can reap huge rewards.

The goal of this 2018 interim subcommittee is to create priorities for what the State of Alaska can do to build a stronger food system and encourage a vibrant entrepreneurial food economy.

Proposed meeting topics and related tours for 2018:

- Workforce Development and Farming on State Lands
 - Look at state land availability for education and training
 - Opportunity for entrepreneurs and owners of unique businesses
 - Build partnerships with the university/cooperative extension/FFA
- Local Food Storage and Infrastructure Development
 - Who is going to build it, where do we get the money, federal farm storage program?
 - Longer shelf life for fresh foods – shared flash freeze facility
 - Traditional Food Store(age) Outside Your Door: A surprising outcome could be
 - Rural farm tours or trips to villages to build systems and have local food experience
- Procurement for Alaska Grown Products
 - Getting more farmers/producers on preferred vendors list
 - Finding new markets – prisons, pioneer homes, hospitals? Healthy, local
- Food Freedom and Removing Regulatory Barriers
 - Rebuilding the dairy industry in Alaska
 - Raw milk sales at farmers markets
 - Increase direct producer to consumer sales
 - Tourism around farm and village food experiences
 - New opportunities with Air BnB Experiences Tours
 - Sharing and incentivizing commercial kitchens – schools in the summer?
